Voting Information

TO VOTE IN THE STATE OF WASHINGTON, you must be a citizen of the United States, at least 21 years of age, duly registered, able to read and speak the English language, and a resident of the state for one year, the county for 90 days, and the precinct for 30 days.

Exception for newcomers to the state: To vote in presidential elections the residential requirement is reduced to 60 days. Call your county auditor for information on how to obtain this special ballot.

TO BE REGISTERED IN YAKIMA COUNTY (rural precincts), you must register with the county auditor (County Courthouse, Yakima, CH 8-2521) or call the county auditor for the address of the registrar of your precinct.

TO BE REGISTERED IN THE CITY OF YAKIMA (city precincts), you must register with the city clerk (City Hall, CH 8-2620).

Registration closes 30 days before each election, including primaries. Re-register if you have not voted at least once in a four year period or have changed your name.

Notify the county auditor or city clerk in writing or in person of a change of address.

ABSENTEE BALLOT

An absentee ballot may be obtained only by the voter or members of his immediate family, from the city clerk or the county auditor, depending upon where the voter is registered. Application may be made no earlier than 45 days before, and no later than day before election. Ballots are usually available 15 to 20 days before election.

An absentee ballot must be returned on or before election day, and in no case postmarked later than the closing hour of polls.

More definite information may be obtained from the county auditor or city clerk.


