History of the facts

For the first specification and first charge lies the immediate cause of the Indian war, for the military failing to go and make inquiry as ordered, into the death of persons said to have been murdered (tho' then there was but one named Mattice) requiring but a day's march out of their course; Indian agent Bolon went alone was injudicious in his threats, tho' suffered such as ______ to leave the Roman Catholic mission some 3x 4 miles; where he was undertaken by a few Indians, some 3 or 4 miles, and still threatening to bring the military upon them, he was there killed and the Indians gathered their forces for war.

The 1st specification 2nd charge speaks for itself --

B.Maj. Haller having called for a court of inquiry and that having been ordered by the Comdg Genl of Dept. it was supposed the subject would be fairly disposed of, but that court from the major's own acts instrumentally has never convened. The charge is therefore presented in specification

For the 2nd specification, 2nd charge the officers of the expedition feeling themselves aggreived appointed Lt. Gracie spokesman who informed the major that they had determined to publish a counter statement as to the reported author and therefore first desired to know if he wrote it he answered "he did." The manuscript was seen when in route for publication by apt. Wallen and the Editor Dryer acknowledged to District Attorney Farrar [?] that Byt. Major Haller wrote it.

Charges and specifications preferred against Brevet Major Granville

Charge 1st"Neglect of Duty."

Specification-In this that Brevet Major G.O. Haller Captain

4th Infantry having received a dispatch for Lieutenant E.H. Day

3rd Artillery commanding a detachment in the field and having received instructions from his commanding officer Major G.J. Rains 4th

Infantry commanding the Columbia Diver District to send the said dispatch to the said (Lieut. Day) as soon as practicable, did fail and neglect to forward said dispatch. This at Fort Dalles O.T. on or about the 19th of September, 1855.

Charge 2nd Misbehaviour before the enemy by making and unnecessary, disorderly and shameful retreat.

Specification-In this that ^Brevet Major ^Granville O. Haller a captain of the 4th ^Regiment U.S. Infantry being in command of a detachment of U.S. ^{Troops} in the Yakima country about 40miles north of the ^Dalles of the ^Columbia O.T. and in presence of hostile ^Indians did wi thout necessity shamefully abandon his position and retreat in disorder from the presence of the enemy did throw away and abandon his artillery, to wit, one mountain howitzer and when re enforced by a detachment of 40 men and a howitzer and no longer pursued by the enemy. did continue to retreat in disorder, till he had crossed the ^Columbia River and reached Fort Dalles.

This on or about the 7th day of Oct. 1855/

Charge 3rd "Violation of the 292th paragraph of the eneral Regulations of 1847 for the Army--

Specification--In this that Brevet Major G. O. Haller, Captain 4th Infantry did make a report relative to the march and operations of his command for publication in the Oregonian a newspaper published in Portland, O.T.

This at Fort D alles O.T. on or about the 6th of October 1855 and within one month after the termination of the campaign to which it relates to wit, the campaign against the Y akima I ndians.

Charge and specifications against

Edward O.C. Ord, 3rd artillery

Charge 1st conduct unbecoming an officer and a gentleman Specification 1st In this that Capt. Edwd O.C. Ord of the 3rd Regt of Artillery U.S.A. did enter the mission house of the Catholic Mission in the Antanum Valley Washington Territory on or about 11th of November 1855 and unlawfully before soldiers did possess himself of apair of boots and other property belonging to the priest; that as an officer setting example to sacking the priest's quarters and that of the church by the soldiery which followed accordingly.

Specification 2nd in this that Capt. Edwrd. O.C. Ord of the 3rd Regt of Artillery at the Roman Catholic mission house specified on or about the 11th of November 1855 when his commanding officer Major G.J. Rains 4th Regiment of Intantry and giving orders not to molest any property belonging to the priest or church except eatables did in contempt therefore continue to put on a pair of boots not his own but the priest's and had some skins folded up not his own property and all were carried away by him

Specification 3rd In this that Capt. Ed. O.C. Ord of 3rd Regt. of Artillery in a newspaper production dated Vancouver $^{W}.$ T. Janu'y 11 1856 published in the New York Herald of 17th of February 1856 does assail ? his late commanding officer in violation of Par. 292 Gen'l Regulations of the army in words following to wit: W"Our expedition went into the Yakima country some 800 strong about 500 volunteers and 300 regulars A big fight was expected but the commanding of ficer of the regulars weas by nature adapted for any thing but a partisan chief. He marched about over plains and mountains, got into rivers, drowned some men lost alot of horses and mules, got into snows, marshes and every type of scrape except a battle (the' there was some chance of it) lost some of his party, burned a Catholic mission and then came in with about the most disgusted set of young army officers and volunteers that we have seen lately. No doubt the chief's report to "ashington state that the expedition had produced great moral effect. No young officer is asked for a true report and so that the truth is not told, it is considered unmilitary to write to the papers to tell the truth 'out of school.' So much for field officers and dear people, you have got hardly any others. The field officers of all the regiments except perhaps the recently created shew young men are put in are all old fogies; they are

to run Indians or ponies as to run down mountains as General Scott is to run into an enemy's govt through a loop hole with due respect to the general

The said Capt. E.D.C. Ord thus mistleading the public and covetly endeavoring to cast public dix odium upon his commanding officers for letting some of his party burn the Catholic mission which he knew to be false.

Charge 2nd Neglect of duty

Specification In this that Capt. E.O.C. Ord of 3rd Tegt. of Arty when ordered by him the commanding gen of Department of the Pacific to report to Major Rains to take the field for active service against the Yakima Indians in an order dated Head 2nd Dept of the Pacific Denecia Oct. 27th 1855 did join at camp opposite Fort Dalles on or about 30th Oct 1855 and did take the field with his company not in proper condition for the campaign for the clothing for himself and company

Charge.. Neglect of duty

Specification: In this that ^Brevt. ^Maj. ^G.O. Haller 4th Infantry at Fort ^Balles O.T. on or about the 19th of September, 1855, did fail to forward to Lieut ^Day of 3rd ^Pegt. of Ertillerycommanding ^E 44 men and one mountain howitzer in the field on the immigrant trail in route to the ^Dalles O.T., a letter forwarded for that purpose with instructions to be sent on as soon as practicable; altho he BBt. ^Maj. G.O. Haller 4th Infy had reason to believe it was an important order from ^Major Rains commanding officer of the district calculated to check hostilities and preserve the peace of the country thus evincing an indifference hereto.

Charge--end--Conduct unbecoming an officer

Specifications lst In this that Brvt. Major G.O. Haller 4th Regt infantry on or about the 7th of October 1855 about 40 miles north from Fort Dalles akima country however deserving of credit otherwise, did improperly dispose of a mountain howitzer, the property of the United States and with his forces did shamefully abandon in precipitate retreat the whole country north of Fort Dalks to the hostile Indians putting the Columbia River between himself and the enemy, tho having received a re-inforcement under Lieut Day of some 40 men of artillery and another mountain howitzer, and tho not pursued by any of the enemy within 25 miles or more from that fort branks sought as his place of safety, which proceding around the whole Indian country for war with the United States.

Specification 2nd in this that Brevt Maj. G.O. Haller 3 4th megt of infantry in violation of paragraph 292 general regulations of 1847 for the army, did and for publication in a newspaper, to the

Charge Contempt and disrepect towards his commanding officers.

Specifications- In this that Capt. E.O.C.Ord of 3rd Regt of firtillery at Fort Dalles, O.T. on or about 9th December 1855 did forward covertly the following accusations set forth in charges and specifications against his commanding officer Major G.J. Rains,4th Infy late commanding the Yakima Expedition thus allowing him no chance to say anything in his defence, the same being untrue, derogatory and malicious.
