Framed pictures on walls, depicting scenes in the High Sierras,
and industries of the county Number 30.
Mountains scenes in dark brown frames, others in white frames.

White Heron in glass case, donated to the Tulare County Board of
Trade when the Board was located in Hyde Park, and moved to
the Auditorium in 1917.

This specie of the White Heron is very very rare, and this one
had been killed by a hawk out in swamps near the old Cottage
post office... was taken from the hawk by the late Mr. Hyde,
father of Misses Inez and Nettie Hyde, of this city.

Silver Cups in the Indian Basket case near the main entrance of the
office, prizes won by the Tulare County Board of Trade, and the silver
cups in the other end of the case are the property of the Visalia
Chamber of Commerce. (Floyd Byrnes turned them over to me to take care
of them as I kept the ones belonging to the Board polished and cleaned.)
