SPECIAL NOTE: Some areas open at the time the pamphlet was printed may have since been closed by military or other authorities. Due to the nature and uncertainty of such closures it is impossible for this Department to put out information or maps concerning closures of this nature. Every license-holder must ascertain at his own peril that he does not enter fire closures, military closures or areas closed for other reasons.

It shall be unlawful to hunt, take or pursue upland game birds, game animals and/or fur-bearing animals in the State of Washington at any time except during the following open seasons, with bag limits as prescribed for each species. PROVIDED, HOWEVER, That it shall be unlawful to hunt, take or pursue upland game birds, game animals and/or fur-bearing animals on lands set aside as State Game Reserves where the hunting, taking or pursuing of such upland game birds, game animals, and/or fur-bearing animals is prohibited. PROVIDED, FURTHER, That all other game birds, game animals and/or fur-bearing animals not specifically mentioned in the following open seasons, are protected by closed seasons, and it shall be unlawful to hunt, take or possess the same at any time.

BLUE GROUSE, RUFFED GROUSE (commonly known as the Native Pheasant), FRANKLIN GROUSE:

General Open Season:

October 7, 8 and 9 in all counties of the state EXCEPT Adams, Benton, Franklin, Grant and Whitman counties, which shall be closed to grouse hunting.

State Game Reserves Open to Grouse Hunting: October 7, 8 and 9 in the following reserves only:

Chelan county Emerald Park Game Reserve
Chelan county Nason Creek Game Reserve
Chelan county White River Game Reserve
Garfield-Columbia counties. Tucannon Game Reserve
Okanogan-Chelan counties Gold Creek Game Reserve
Whatcom county Mt. Baker Game Reserve
Yakima county Rattlesnake Game Reserve

Bag Limit: Two (2) grouse per day or a total of two (2) in possession at any one time, straight or mixed bag.

CHINESE PHEASANTS:

General Open Season:

October 14 to November 4, both dates inclusive, in all counties of the state.

Bag Limit: Three (3) cocks per day or a total of six (6) cocks in possession at any one time. (No open season on hens) PROVIDED, Each person desiring to possess more than the daily bag limit of three (3) cocks must have each day's bag tagged by a game protector or person authorized by the Department of Game (OR ALL AUTHORIZED LICENSE DEALERS).

HUNGARIAN PARTRIDGES:

General Open Season:

October 14 to November 4, both dates inclusive, in all counties east of the summit of the Cascade Mountains and in Whatcom, Skagit and Snohomish counties in western Washington. All other counties are closed to the hunting of Hungarian partridges.

Bag Limit: Three (3) Hungarian partridges per day or a total of three (3) in possession at any one time.

QUAIL.

General Open Season:

October 14 to November 4, both dates inclusive, in all counties of the state.

Bag Limit: Ten (10) quail per day or a total of twenty (20) quail in possession at any one time; PROVIDED, Each person desiring to possess more than the daily bag limit of ten (10) quail must have each day's bag tagged by a game protector or person authorized by the Department of Game (OR ALL AUTHORIZED LICENSE DEALERS).

GENERAL UPLAND GAME BIRD REGULATIONS:

Hunting Hours for Upland Game Birds: Tables on pages 11 and 12 show lawful shooting hours for upland game birds.

Badger Pocket Hunting Area: It shall be lawful to hunt Chinese pheasants (cocks only), Hungarian partridges and quail during the regular open season only, for a distance of one mile south of the High Line Irrigation Canal in Badger Pocket, said area being within the boundaries of the Squaw Creek Game Reserve in Kittitas county.

Sinlahekin Reserve Bird Hunting: It shall be lawful to hunt Chinese pheasants (cocks only), Hungarian partridges, migratory waterfowl and quail, on general open season dates, within the boundaries of the Sinlahekin Game Reserve in Okanogan county.

MEANS OF TAKING:

Unplugged gun unlawful: It shall be unlawful for any person in the State of Washington to hunt, take or pursue upland game birds, migratory waterfowl and birds with a shotgun holding or having a capacity for holding more than three shells: PROVIDED, HOWEVER, That this shall not prohibit the possession of such automatic loading or hand-operated repeating shotgun providing the magazine thereof shall have been cut off or plugged with a one-piece metal or wooden plug or filler incapable of removal through the loading end thereof and which plug reduces the capacity of said magazine to two shells.

Unlawful to disguise sex or kind: It shall be unlawful for any person to have in possession while in the field or forest. or while upon any highway, train, car, boat or any other conveyance during any hunting trip, any game bird, the carcass of which has been plucked or mutilated in any manner so as to disguise the species, kind or sex thereof.

DEER: (See gun regulation on page 13)

General Open Season:

October 7 to 28, both dates inclusive, in all counties of the state EXCEPT Adams, Benton, Franklin, Grant and Whitman counties, which shall be closed to deer hunting.

State Game Reserves Open to Deer Hunting: October 7 to 28, both dates inclusive, in the following reserves only:

Chelan county Emerald Park Game Reserve
Chelan county Nason Creek Game Reserve
Chelan county White River Game Reserve
Garfield-Columbia counties. Tucannon Game Reserve
Okanogan-Chelan counties. Gold Creek Game Reserve
Whatcom county Mt. Baker Game Reserve
Vakima county Rattlesnake Game Reserve

SPECIAL DEER SEASONS: (Note: All special seasons are established to relieve game damage to agricultural crops.)

Whidby Island Special Deer Season: Island county. Open season: October 7 to 28, both dates inclusive.

Bag Limit: One (1) deer of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to remove any deer from the described special open area without first having such deer tagged by a game protector or authorized representative of the Department of Game.

Open area: Whidby Island in Island county.

PACIFIC COUNTY SPECIAL DEER SEASON: Portion of Pacific county.

Open season: September 2, 3, 4 and 5.

Bag Limit: One (1) deer of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include all lands within the following described boundaries: Beginning at the mouth of the Bear River on Willapa Bay; thence up the Bear River to the point where it is crossed by U. S. Highway 101; thence in a westerly direction along said highway to the point where it is joined by the Walicut Cut-off Road; thence south on said Walicut Cut-off Road to the point where it is crosses the Walicut River or Slough; thence down the westerly bank of the Walicut River to the point where it joins the Columbia River and continuing in a westerly and northerly direction down the north shore of the Columbia River and along the Pacific Ocean Beach to a point due west of Ocean Park; thence due east across the Long Beach Peninsula to the shore of Willapa Bay; thence in a southerly and easterly direction along the shore of Willapa Bay to the mouth of the Bear River and point of beginning.

WHEELER HILL SPECIAL DEER SEASON: Chelan county. Open season: October 3 and 4.

Bag Limit: One (1) antlerless deer, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include all lands lying within the following described boundaries: Beginning at a point on the west bank of the Columbia River where it is intersected by the south line of Sec. 16, Twp. 21 N., R. 22 E. W. M.; thence in a northwesterly direction along the west bank of the Columbia River to the point where Dry Gulch meets the river; thence in a westerly direction up Dry Gulch Creek bed to the point where it is crossed by the range line between R. 19 E. W. M. and R. 20 E. W. M.; thence south on said range line to the southwest corner of Sec. 6, Twp. 21 N., R. 20 E. W. M.; thence easterly on the south lines of Secs. 6, 5, 4 and 3 of said Twp. to the point where the Wheeler Hill Road crosses the south line of Sec. 3; thence in a southerly direction up the Wheeler Hill Road to the point where it crosses the south line of Sec. 15, Twp. 21 N., R. 20 E. W. M.; thence east on Sec. lines to the point where the south line of Sec. 16, Twp. 21 N., R. 22 E. W. M. intersects the west bank of the Columbia River and point of beginning.

LEAVENWORTH SPECIAL DEER SEASON: Chelan county. Open Season: October 3 and 4.

Bag Limit: One (1) antierless deer, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include the following described lands: All lands lying within one mile of the road from Plain north to the point where said road crosses Clear Creek; all lands lying within one mile of the highway from Plain to Leavenworth

passing through the Chumstick Valley; all lands lying within one mile of the Eagle Creek Road between the Chumstick Highway and the point where the Sugarloaf Mountain Road leaves the Eagle Creek Road; all lands lying within one mile of the Wenatchee River between the mouth of Chumstick Creek and the mouth of Icicle River; all lands lying within one mile of Icicle River between the mouth of Icicle River and the point where it crosses the National Forest Boundary; and all of those lands lying north of the Wenatchee River that are within two miles of the north bank of the Wenatchee River between the town of Leavenworth and the point where the Wenatchee River empties into the Columbia River.

LOWER LAKE CHELAN SPECIAL DEER SEASON: Chelan county.

Open Season: October 3 and 4.

Bag Limit: One (1) antierless deer, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include all lands lying within the following described boundaries: Beginning at the Beebe Bridge over the Columbia River at Chelan station; thence in a northwesterly direction along the highway to the town of Chelan; thence westerly out of Chelan on the Chelan-Manson Highway to the point where said highway is joined by the Cooper Mountain Road; thence northerly up the Cooper Mountain Road through Cooper Gulch to the point where said road crosses the township line between Twp. 28 N., and Twp. 29 N.; thence west on said Twp. line crossing Lake Chelan to the point where the line intersects the west shore line of Lake Chelan; thence northwesterly up the west shore line of the lake to the point where Resc. 23 and 24 of Twp. 29 N., R. 20 E. W. M.; thence south on the east lines of Secs. 23, 26 and 35 of Twp. 29 N., R. 20 E. W. M. to the point where said line intersects the Twenty-five Mile Creek, Lake Creek Road and said road is joined by the road up Twenty-five Mile Creek; thence southerly up said Twenty-five Mile Creek Road; thence easterly and southerly up the Slide Ridge Road; thence easterly and southerly up the Slide Ridge Road to its end near Windy Camp and continuing on the trail to the point where it intersects the Summit Trail near Stormy Mountain; thence southeasterly down the Summit Trail over Baldy and Forest Mountains to the point where said trail meets the Johnson Creek Road; thence easterly down the Johnson Creek Road; thence easterly down the Navarre Coulee Road; thence southerly down the Navarre Coulee Road; thence southerly joins State Highway No. 10; thence due east to the Columbia River; thence northerly up the Columbia River to the Beebe Bridge and point of beginning.

METHOW VALLEY SPECIAL DEER SEASON: Okanogan county.

Open Season: October 3 and 4.

Bag Limit: One (1) antlerless deer, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before

leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include all of the following described lands: All lands lying within one mile of the Methow River between the mouth of the Methow River at Pateros and the town of Carlton; all lands outside of the National Forest boundary in the watershed of the Methow River above the town of Carlton; all privately owned lands inside the National Forest boundary on the main or south fork of the Methow River. (Mazama district)

BLYN AREA SPECIAL DEER SEASON: Clallam and Jefferson counties.

Open Season: September 30 to October 5, both dates inclusive.

Bag Limit: One (1) deer of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 24 hours after the close of this special season.

Open area: The lawful hunting area shall include the following described lands: All lands within the following described boundary; beginning at the point where the Palo Alto Road joins the Olympic Loop Highway near Sequim State Park; thence southerly on the Palo Alto Road to the point where it is joined by the Jimmy-come-lately Creek Road near the Louella Guard Station; thence easterly on the Jimmy-come-lately Creek Road near the Louella Guard Station; thence easterly on the Jimmy-come-lately Creek Road to its junction with the road from the Snow Creek Guard Station; thence down the Snow Creek Guard Station Road to its intersection with the Olympic Highway near Blyn; thence easterly a short distance along the Olympic Highway to the point where it is joined by the Burlingame Road; thence in an easterly direction along the Burlingame Road to the point where it again meets the Olympic Highway near Maynard on Discovery Bay; thence due east to the shore of Discovery Bay; thence in a northerly direction following the shore line of Discovery Bay and continuing around the shore of the Blyn Peninsula to a point on the shore line of Sequim Bay due east of the junction of the Olympic Highway and Palo Alto Road; thence due west to said junction and point of beginning; and in addition all lands lying within one mile of the above described boundary on the outside

NORTHEASTERN WASHINGTON SPECIAL DEER SEA-SON: Parts of Spokane, Stevens and Pend Oreille counties.

Open Season: November 4, 5, 6 and 7.

Bag Limit: One (1) deer of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any deer killed in this special open area which has not been tagged by a game protector or person authorized by the Department of Game. All deer transported out of the area shall be tagged before leaving such area and all deer retained within such open area shall be tagged not later than 48 hours after the close of this special season.

Open area: The lawful hunting area shall include the following: That part of Spokane county lying north of the Spokane River including the Little Spokane River Game Reserve.

That part of Stevens county lying east of the Columbia River and outside the National Forest boundary and outside the Little Pend Oreille Wildlife Refuge. (National Forest, Little Pend Oreille Wildlife Refuge and land west of Columbia River closed to hunting

Pend Oreille county—Those lands on the east side of the Pend Oreille River that are within three (3) miles of the east bank of the Pend Oreille River between the Ione Bridge and the Idaho line; those lands on the west side of the Pend Oreille River that are within three (3) miles of the west bank of the Pend Oreille River between the Ione Bridge and the town of Dalkena; those lands in the southern part of Pend Oreille county lying south of the Pend Oreille River from the Idaho line to Dalkena, south of the Dalkena-Middle Fork Calispel Creek Road from Dalkena to the National Forest boundary and outside the National Forest boundary.

BOW AND ARROW SEASONS: (Areas open only to bow and arrow hunting.)

MAD RIVER BOW AND ARROW AREA: Chelan county

Open Season: October 7 to 28, both dates inclusive, PROVIDED. That it shall be unlawful to hunt game animals and game birds for which there is an open season as provided by these regulations, in any other manner than with bow and arrow within the area of Chelan county described below during the period October 7 to 28, both dates inclusive.

Bag Limit: One (1) buck deer having at least one branched antler. The head of said deer shall remain with the carcass thereof while in transportation. Other game animals and game birds; same as provided in

these regulations.

Open area: The area wherein lawful hunting may be done only with a bow and arrow during the period shown shall include all lands within the following described boundaries: Beginning at a point near Maverick Peak where the Mad River Trail joins the Entiat Summit Road in Sec. 16, Twp. 27 N., R. 18 E. W. M.; thence in a southeasterly direction down said Mad River Trail to the point where it is joined by the Cougar Creek Trail in Sec. 23, Twp. 27 N., R. 18 E. W. M.; thence northerly up said Cougar Creek Trail to a point one-half mile more or less due east of Cougar Mountain; thence due west to Cougar Mountain; thence in a northerly direction on a straight line drawn between Cougar Mountain and Klone Peak to a point near Devil Lake, where said line is intersected by the Klone Peak Trail; thence in a northerly direction down the Klone Peak Trail to the point where it joins the Entiat River Road one mile more or less to the point where said road is joined by the Three Creek Trail in Sec. 16, Twp. 29 N., R. 18 E. W. BAINBRIDGE ISLAND BOW AND ARROW AREA: Kitsap

Open Season: October 7 to 28, both dates inclusive, PROVIDED, That it shall be unlawful to hunt, take or pursue deer on Bainbridge Island in any other manner than with bow and arrow during the special season, October 7 to 28, both dates inclusive.

Bag Limit: One (1) deer of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful

to remove any deer from this open area without first having same tagged by a game protector or person authorized by the Department of Game.

Open Area: Bainbridge Island, Kitsap county.

NOTE: Any season or area open to hunting with firearms is also open to bow and arrow hunting and the same limits and license requirements apply to both.

BEAR: Western Washington (all counties lying west of the summit of the Cascade Mountains)

Open Season:

Year around or the entire year EXCEPT. That it shall be unlawful to hunt or kill bear during the elk season in all counties open to elk hunting.

State Game Reserve Open to Bear Hunting: October 7 to 28, both dates inclusive, in the Mt. Baker Game Reserve, Whatcom county.

Bag Limit: Two (2) bear per calendar year.

BEAR: Eastern Washington (All counties lying east of the Summit of the Cascade Mountains)

Open season

October 7 to 28, both dates inclusive, in all counties having an open deer season.

State Game Reserves Open to Bear Hunting: October 7 to 28, both dates inclusive, in the following reserves only:

Chelan county Emerald Park Game Reserve Chelan county Nason Creek Game Reserve Chelan county White River Game Reserve Garfield-Columbia counties. Tucannon Game Reserve Okanogan-Chelan counties Gold Creek Game Reserve Yakima county Rattlesnake Game Reserve

Bag Limit: One (1) bear.

ELK: (See gun regulation on page 13)

General Open Season:

November 4 to 13, both dates inclusive, in the followcounties only:

Asotin Grays Harbor Mason Chelan Garfield Pacific Clallam Jefferson Walla Walla Columbia Kittitas Yakima

State Game Reserves Open to Elk Hunting:

November 4 to 13, both dates inclusive, in the following reserves only:

Bag Limit: One (1) elk with visible horns, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That all elk killed in Columbia, Garfield and Asotin counties must be checked at a Game Department checking station not later than 48 hours after close of the season.

SPECIAL ELK SEASONS: (Open to elk of either sex).

Blue Mountains Special Elk Season: Parts of Asotin,
Columbia and Garfield counties.

Open Season: November 4 to 13, both dates inclusive.

Bag Limit: One (1) elk of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any elk killed in this special open area which have not been tagged by a game protector or person authorized by the Department of Game. All elk transported out of the area shall be tagged before leaving such area and all elk retained within such open area shall be tagged not later than 48 hours after the close of this special season.

Open area: The lawful hunting area shall include the following described lands: All lands of Asotin county lying outside the National Forest boundary and the Fordyce and Horak deeded lands lying within the Forest boundary. That part of Garfield county lying outside the National Forest boundary between the Garfield-Asotin county line and the Mountain Highway and bounded on the north by the Pomeroy-Clarkston Highway, and all lands lying outside the National Forest boundary in the Grouse Flat area of Garfield county. That part of Columbia county lying within the following described boundary: Beginning at the point where the Patit Creek Road leaves the town of Dayton; thence easterly up the Patit Creek Road to the point where it is joined by the Lewis Gulch Road; thence in a southerly direction along the Maloney Mountain Road to the point where it meets the Skyline Road; thence in a southerly direction along the Skyline Road; thence in a southerly direction along the Skyline Road to the point where it is joined by the Jim Creek Trail; thence in a westerly direction down the Jim Creek Road and continuing down the Jim Creek Road and continuing down the Jim Creek Road to the point where it meets the Jim Creek Road and continuing down the Jim Creek Road to the point where it joins the road down the North Fork of the Touchet River; thence northwesterly down the Touchet River; thence northwesterly down the Houchet River; thence northwesterly down to the point of beginning.

HUMPTULIPS RIVER SPECIAL ELK SEASON—GRAYS HARBOR COUNTY

Open Season: October 29, 30, 31 and November 1.

Bag Limit: One (1) elk of either sex, the head of which shall remain with the carcass thereof while in transportation. PROVIDED, That it shall be unlawful to possess any elk killed in this special open area which have not been tagged by a game protector or person authorized by the Department of Game. All elk transported out of the area shall be tagged before leaving such area and all elk retained within such open area shall be tagged not later than 48 hours after the close of this special season.

Open area: The lawful hunting area shall include all lands lying within the following described boundary: Beginning at the point where the township line between Twps. 18 and 19 N., intersects State Highway 9-C near the town of Wilderness; thence east on said township line to the point where it meets the Grays Harbor-Mason county line; thence north on the Grays Harbor-Mason county line; thence north on the Grays Harbor-Mason county line to the point where said line intersects the township line between Twps. 20 and 21 N.; thence west on said township line to the point where it intersects the range line between ranges 8 and 9 W. W. M.; thence north on said range line to the point where it meets the National Forest boundary to a point due north of Abel's Logging Camp; thence northerly and westerly along the National Forest boundary to a point due north of Abel's Logging Camp in Sec. 10, Twp. 21 N., R. 9 W. W. M.; thence south 100 feet more or less to Abel's Logging Camp; thence in a southwesterly direction along the Abel Logging Road to the point where it meets the Olympic Highway in Sec. 5, Twp. 21 N., R. 10 W. W. M.; thence across the highway and continuing westerly on the Pump Curve Road of the Polson Logging Company to the point where said road crosses the Chepalis River in Sec. 30, Twp. 21 N., R. 10 W. W. M.; thence southerly down the Chepalis River to the point where it is crossed by State Highway 9-C; thence southeasterly along said highway to the point where it crosses the township line between townships 18 and 19 N., and point of beginning.

HUNTING HOURS FOR DEER, ELK AND BEAR: One-half hour before sunrise to sunset.

LEGAL LIMIT OF GAME: One deer and one elk are still the yearly limits per hunter. A hunter taking a deer or elk in a special season occurring before the regular seasons is automatically disqualified from hunting in the regular deer or elk season of that year.

RABBITS: (Cottontail and Snowshoe)

General Open Season:

October 14, 1945, to February 28, 1946, both dates inclusive, in all counties of the state, EXCEPT, That it shall be lawful to hunt, take or pursue rabbits during the entire year in Clark and San Juan counties and on Whidby Island in Island county, EXCEPT closed season in Clark county from September 1 to October 13, both dates inclusive.

Bag Limit: Five (5) rabbits per day, straight or mixed bag, or in possession at any one time. EXCEPT, no bag limit in Clark and San Juan counties and on Whidby Island in Island county.

Hunting Hours for Rabbits: One-half hour before sunrise to sunset.

SQUIRRELS: (Gray Squirrel and Black Squirrel) CLOSED SEASON

FUR-BEARING ANIMALS: (Except BEAVER AND FISHER, closed season)

General Open Season: (Except Marten) November 15, 1945, to January 15, 1946, both dates inclusive

Provided: It shall be unlawful to trap muskrat in muskrat mounds or houses.

Provided: It shall be lawful to trap fur-bearing animals within the boundaries of the Lake Washington, Pierce county, Littie Spokane and Burnt Bridge Creek Game reserves from November 15, 1945, to January 15, 1946, both dates inclusive.

Provided: It shall be lawful for any person holding a trapper's license to hunt raccoon with dogs from November 15, 1945, to January 15, 1946, both dates inclusive.

Provided: It shall be unlawful for any person to shoot fur-bearing animals except raccoon with any firearms whatsoever; and it shall be unlawful to shoot or pursue raccoon with a firearm between sunset and one-half hour before sunrise.

Bag Limit: No limit.

SPECIAL MARTEN SEASON:

December 1, 1945, to January 1, 1946, both dates inclusive, PROVIDED, That the taking of marten during this special season shall be open to all licensed trappers who shall strictly abide by the following requirements:

(1) It shall be unlawful for any trapper to use more than 36 traps.

(2) Within thirteen (13) days after the close of the lawful open season on marten each trapper shall present his skins for tagging and inspection to the local game protector in the area in which he traps; AND, at that time the said game protector shall tag each skin. PROVIDED, That it shall be unlawful to sell any marten skins not so tagged, and, that on and after January 15, 1946, it shall be unlawful for any person to possess any marten skins not so tagged.

Bag Limit: No limit.

1945 CONTROLLED HUNTING AREAS:

The following special hunting season and regulations thereto were fixed in compliance with Chapter 126, Session Laws of 1941.

Controlled hunting seasons are adopted as corrective measures only. They are established only for the purpose of handling private property and range damage com-plaints. Controlled hunting areas are not necessarily areas where unusually good hunting conditions will be found.

General Instructions:

Persons desiring to participate in this drawing must personally make written application to the office of the Department of Game, 515 Smith Tower, Seattle 4, Washington.

Important: Applications must be made on a one cent (1¢) postcard which may be secured at any United States postoffice or postal station. Cards must contain the following information:

(1) Name and address of applicant. (2) Number and name of area which applicant desires to hunt.

(3) Applicant must give the number of his 1945 hunting license.

(4) Applicant must certify that he has not killed, an elk in any other 1945 hunting season.
(5) Cards shall be mailed to the Department of Game, 515 Smith Tower, Seattle 4, Washington.

NOTE: Two persons may apply together. If two persons desire to hunt together, they may make application on a single postcard. If the card is drawn, both applicants will receive special hunting permits. No more than two applications will be accepted on any one card.

WARNING: Any person entering his name on more than one application for the controlled hunt will be eliminated entirely from the drawing. Applications received by the Department of Game which do not contain the above information or do not comply with the above requirements and those received after the closing date and hour listed for the area will not be eligible to be drawn.

Applicants are not required to be present at the drawing. The drawing will be supervised by two resident citizens of the county in which the special season is held Persons whose names are drawn will be notified by mail from the Department of Game.

Permits are not transferable. All hunters are required to check into the controlled hunting area at Department of Game checking station.

All elk killed must be tagged by a game protector or person authorized by the Department of Game before being transported outside of the area.

It shall be unlawful for any person to hunt, pursue, shoot at, take or kill any elk, deer or bear in the State of Washington while using any shell or cartridge containing, using, shooting or firing any full metal cased bullet. (Regulation No. 649, passed at regular meeting of State Game Commission July, 1944)

Tagging Requirements: All fur-bearing animals, game animals, upland game birds and migratory waterfowl, and all parts thereof, in possession of any person, firm or corporation, other than the person who shot or took the same shall have attached thereto a written statement made and signed by the person who shot or took the same, setting out his license number, the date when shot or taken, and the name of the county in BOUNTY ON PREDATORY ANIMALS: which the same was shot or taken.

Any such person who fails to so make and sign such statement shall be guilty of a misdemeanor.

Any other person, firm or corporation in possession of such fur-bearing animal or game animal or bird, or waterfowl, or part thereof, without having such written statement so attached, shall be guilty of a misdemeanor. (Regulation passed at regular meeting of State Game Commission October 10, 1933.)

Time Limit for Possessing Game Animals and Upland Game Birds: It shall be unlawful for any person to thereof after March 1st following acquisition thereof, and it shall be unlawful for any person to have in his possession any big game animal or part thereof after March 1st following acquisition thereof, and it shall be unlawful for any person to have in his possession any big game animal or part thereof after July 1st following acquisition thereof. PROVIDED, That anyone in lawful possession of any upland game hird or part thereof are now hird game are the person to the person the person to the person bird or part thereof, or any big game animal, or part thereof, may have the same in possession after said dates upon procuring a permit from the Director of Game or his duly authorized agents, authorizing such permittee to have the same in his possession. However, nothing herein shall prohibit the lawful possession of mounted trophies and pelts in the manner provided by law.

Wastage Law: Any person who, at any time kills, captures or destroys any game animal of this state, and detaches or removes from the carcass only the head, hide, antlers, horns, tusks or any or all of the aforesaid parts, is guilty of a gross misdemeanor, and upon conviction thereof shall be fined not less than \$250.00 and not more than \$1,000.00 or by imprisonment in the county jail for not more than one year or by both such fine and imprisonment. The purpose and intent of this section, is to protect game animals of the state from wanton, ruthless or wasteful destruc-tion or mutilation for their heads, hides, antlers, horns or teeth or tusks alone, and its provisions are to be so construed. The failure of any person to properly dress and care for any game animal killed by such person or persons, within twenty-four hours, and to take or transport to the camp of such person or persons such carcass and there properly take care of the same shall be prima facie evidence of the violation of the provisions of this section. Any person who, at any time, after killing any game animal, game bird, game fish, or fur-bearing animal of this state, leaves such animal, birds, or fish to needlessly go to waste shall be guilty of a misdemeanor. (L. '29, P. 606, Sec. 13.)

Denial of License to Certain Individuals: RESOLVED, That no hunting or fishing license shall ever be issued or sold to or held by any person who while hunting, shall have ever shot at or shot any human being, or who, while hunting shall have shot any domestic animal belonging to another, until after such person shall have hear given a heavily the form the State Comme shall have been given a hearing before the State Game Commission, after which the Commission shall de-termine whether any license shall ever be issued to such person.


Use of Firearms by Minor: No minor under the age of se of Firearms by Minor: No minor under the age of fourteen years shall handle or have in his possession or under his control, except while accompanied by or under the immediate charge of his parent or guardian, any firearm of any kind for hunting or target practice or for other purposes. Every person violating any of the foregoing provisions or aiding or knowingly permitting any such minor to violate the same, shall be guilty of a misdemeanor. - 2. Any holder of a resident hunting and fishing license may collect bounty. Such license must have been issued before predator was taken.
- 3. Any person under 16 years of age, who has been a resident of the state for six (6) months will not be required to have a license in order to collect
- 4. Game protectors are authorized to check predators and certify bounty claims.
- 5. You must furnish the game protector with the date, also the name of the county in which each predator was taken.
- 6. The hind leg bones must be left attached to the pelt when the predator is presented for bounty.
- The predator must be bountied in the district in which it was taken.
- It is unlawful to claim bounty on a predator taken by a person other than yourself.
- 9. It is unlawful to hunt predators on a game reserve without the written permission from a state game protector.
- Every person who shall give untrue or misleading information as to the time, area or county in which the predator was taken, is subject to a fine of not less than \$250 nor more than \$1,000 and a year in jail.

GENERAL INSTRUCTIONS: Make the first Shot Count:



Do not kill a game animal in any area where it is impossible to pack it out. Never kill an elk without first making arrangements to have it packed out after the kill. Report any violation of the game laws to a game protector or the State Game Department, 515 Smith Tower, Seattle, Washington. El. 2633.

Instructions for the Care of Big Game: Any person hunting deer or elk should have in possession or available for his use the following equipment:

A good skinning knife.
 A hand axe or hatchet.

Rope enough to hang up a deer or the four quarters of an elk.

Muslin or cheesecloth sufficient to cover a deer or

the quarters of an elk.

Canvas sufficient to protect meat from rain or to roll deer carcass in if desired.

Care of Deer: Immediately after killing, a deer should be bled. Then it should be hung up and dressed by opening the entire length of the belly from the base of the tail to the front of the ribs. All viscera in-cluding heart and liver should be removed to speed cooling. Then it should be propped open and allowed to cool at least over one night. If flies are present it should be wrapped with muslin or cheese-

present it should be wrapped with muslin or cheese-cloth. All moisture should be wiped out of the carcass and it should never be washed with water, or be allowed to become wet from rain.

Some hunters successfully care for meat in warm weather by hanging the deer in the open at night and taking it down when still cool in the morning and wrapping it in a large canvas and depositing it in a cool shady place during the day.

Where possible it is always best to take a deer to a local cold storage plant if it is to be held for several

Care of Elk: Elk is handled much the same as deer except that it should also be skinned and quartered at the time that it is dressed. The quarters will re-

main in best condition if they can be placed in muslin bags. They should be hung in a well ventilated place as they cool much more slowly than deer. It is very important that the meat be kept completely dry at all

Tagging with Big Game Seal: On male deer and elk the big game seal shall be placed and locked around the base of the branched antler. The seal so placed must be the one issued to the person killing the animal. Where female or spike deer or elk are taken the big game seal should be attached through a hole pierced

Immediately after the close of the season the Report of Hunt card must be filled out and mailed to the

Hunting: Any person, including those under the age of 16 years, must have a license to hunt game birds and game animals.

Trapping: Any person, including those under the age of 16 years, must have a trapping license to take furbearing animals.

Duck Stamp: Any citizen under the age of 16 years may hunt migratory waterfowl without a duck stamp.

Bounty: Any resident citizen under the age of 16 years may collect bounty on certain predatory animals with-out a hunting and fishing license.

COOPERATION WITH FARMERS: Since small game hunting is conducted largely on privately-owned farm

lands, your favorite sport depends on your being a good sportsman. When you hunt on a farm, recognize the fact that you are in reality the guest of the farmer. Respect him accordingly, aid in protecting his property, and less land will be posted against hunting. He will be your friend if you and other hunters treat him honor-

EVERY GOOD SPORTSMAN WILL:

Ask a farmer's permission to hunt on his land. Park your car where it won't interfere with him.
 Never cut or otherwise damage fences, nor leave gates

open or bars down, nor destroy posters. Never shoot near buildings or livestock, nor where men are working.

Never overlook an act of vandalism or a violation of law by another hunter. Report such acts to the proper person, either a game protector, the farmer or person in charge of the land. Cultivate the friendship of the farmer or the person

in charge of the land.

TEN COMMANDMENTS OF SAFETY: REMEMBER the gun is ALWAYS loaded-even when you are positive that it is not. These are just a few of the rules laid down by a careful hunter:

TREAT every gun with the respect due a loaded gun. This is the cardinal rule of gun safety.

CARRY ONLY empty guns, taken down or with the action open, into your automobile, camp, and home.

3. ALWAYS be sure that the barrel and action are clear

of obstructions.

ALWAYS carry your gun so that you can control the direction of the muzzle even if you stumble.

BE SURE of your target before you pull the trigger. NEVER point a gun at anything you do not want to

shoot NEVER leave your gun unattended unless you unload it first.

NEVER climb a tree or a fence with a loaded gun.

NEVER shoot at a flat hard surface or the surface of water.

10. DO NOT mix gunpowder and alcohol.

1945 Migratory Waterfowl and Migratory Game Bird Regulations for the State of Washington

GENERAL OPEN SEASONS:

Ducks, Coot, Geese and Brant (except Ross's Goose and Swan—closed season)—October 14 to December 31, 1945, both dates inclusive, in all counties in the state. Except: It shall be unlawful to hunt, take or pursue geese in Walla Walla, Klickitat, Franklin and Benton counties at any other time than on Sundays, Mondays and Thursdays during the period October 14 to December 31, 1945, both dates inclusive.

Wilson's Snipe or Jacksnipe and Rails and Gallinules (ex-

cept Coot)—Season closed.

Band-tailed pigeons—September 16 to October 15, 1945, both dates inclusive.

BAG LIMITS:

5.00

Ducks (except American and Redbreasted Mergansers): Daily Bag Limit—Ten (10) ducks, straight or mixed bag, except such limit may not contain more than one (1) wood duck.

Possession Limit—Twenty (20) ducks, straight or mixed bag, except such limit may not contain more than one (1) wood duck.

American and Redbreasted Mergansers:

Daily Bag Limit-Twenty-five (25) singly or mixed bag.

Geese and Brant (except Ross's Goose):

Daily Bag Limit—Two (2) including Brant but not in-cluding Snow or Whitefronted geese, and in addition four (4) singly or mixed bag of Snow and Whitefronted geese

Possession Limit—Four (4) geese including Brant, but not including Snow or Whitefronted geese, and in addition not more than eight (8) singly or mixed bag of Snow and Whitefronted geese.

Coot—Twenty-five (25) per day and not more than twenty-five (25) in possession at any one time.

Band-tailed Pigeons—Ten (10) per day and not more than ten (10) in possession at any one time.

ote: Only one daily bag limit of migratory game birds is allowed in possession on the first day of the season.

HUNTING HOURS: See pages 11 and 12 for schedule of lawful shooting hours.

POSSESSION TIME LIMIT: It shall be unlawful to have in possession migratory waterfowl or birds which were in possession higratory waterfown or birds which were taken in this state more than ninety (90) days after the close of the open season; and it shall be unlawful to have in possession migratory waterfowl or birds which were taken outside this state, more than ninety (90) days after the close of the open season in the state or country in which they were taken.

MEANS OF TAKING:

EANS OF TAKING:
Feeding and Live Decoys Illegal: It shall be unlawful for any person to hunt or take migratory waterfowl or birds by the aid or use, directly or indirectly, of corn, wheat, oats or other grain or products thereof, salt, or any kind of feed whatsoever, placed, deposited, distributed, scattered, or otherwise put out whereby such waterfowl or birds are lured, attracted, or enticed, regardless of the distance intervening between any such waterfowl or birds are lured, attracted, or enticed, regardless of the distance intervening between any such grain, salt, or feed and the position of the taker; and it shall be unlawful to hunt migratory waterfowl by the use, directly or indirectly, of live duck or goose decoys, regardless of the distance intervening between any such live decoys and the position of the taker. Illegal Devices and Boats: It shall be unlawful for any person to use any sink box, sink boat, sneak boat or any water craft not propelled by hand with side oars not less than five feet in length, and one oar to be used on each side thereof, and the person rowing therein to

on each side thereof, and the person rowing therein to be used on each side thereof, and the person rowing therein to be in an upright position and visible at all times from the waist up while hunting migratory game birds.

Rifles and Pistols Banned: It shall be unlawful for any person to shoot at any migratory game birds with a rifle or a pistol within the State of Washington.

FEDERAL REGULATION:

All persons over sixteen years of age, hunting migratory waterfowl, are required to have in their personal possession an unexpired federal migratory bird hunting session an unexpired federal migratory bird hunting stamp, validated by their signature written across the face thereof in ink.

HUNTING CLOSURE—COLUMBIA AND SNAKE RIVER
It shall be unlawful to hunt migratory game birds or
migratory waterfowl upon or within one-quarter mile
of that part of the Columbia River lying between the
railroad bridge across the Columbia River at Wishram,
Klickitat county, and the Grand Coulee Dam; AND, it
shall be unlawful to hunt migratory waterfowl within
one-quarter mile of the Snake River in Franklin or
Walla Walla counties; AND, it shall be unlawful to
hunt migratory waterfowl within one-quarter mile of
the Snake River in Columbia. Garfield, Asotin and the Snake River in Columbia, Garfield, Asotin and Whitman counties except that part thereof which constitutes the boundary between the states of Washington and Idaho.
