# SPECIAL NOTICE RELATING TO LICENSE FEES TO BE CHARGED RESIDENTS OF OREGON AND IDAHO

Washington State laws require that residents of Oregon and Idaho shall pay the same fees for hunting and fishing licenses in the state of Washington as residents of Washington are charged in the respective states of Oregon and Idaho.

Following is a special schedule of non-resident license fees presently being charged residents of Washington in the states of Oregon and Idaho. Residents of either of those states purchasing non-resident licenses shall pay the fees shown in the schedule below for their respective states.

State, resident citizen trapping license. (This license permits any citizen of the United States, or person who has in good faith declared his intention of becoming a citizen of the United States, and who has been an actual resident of this state for six months, to trap fur-bearing animals for their hides or pelts only in a manner and according to restrictions prescribed by law.)

# LICENSE DEALER FEES

State law requires license dealers to charge for issuance of licenses according to the following schedule:

Any State hunting or fishing license. \$.25
Any County hunting or fishing license. \$.15

The law provides that any person, regardless of age, must have a proper license to hunt for game birds, game animals and migratory waterfowl.

Any minor under the age of sixteen years, who is an actual resident of this state, does not require a license to fish for game fish in the State of Washington.

The State Game Commission does not have authority to make any changes in license requirements or conditions as stated above.

# AN APPEAL TO SPORTSMEN

Protect fish and game by preventing forest fires. Be careful with your camp fires and matches. After smoking, put out all lighted material.

Respect the rights of the landowner. He regards the man as an outlaw who leaves his gates open, cuts his fences, or disturbs his livestock.

If an undersized fish is accidentally caught, wet your hands and remove the hook as carefully as possible. If the fish is deeply hooked, cut the leader and release the fish.

Clean your fish as you catch them. Uncleaned fish spoil quickly in warm weather. Pack your catch in ferns or grass and it will keep better.

# 1950 OPEN SEASONS AND CATCH LIMITS ON GAME FISH IN THE STATE OF WASHINGTON

TROUT AND OTHER GAME FISH—(Except Whitefish)—SEASON:

See individual counties for opening dates.

# WHITEFISH—SEASON:

Eastern Washington—December 10, 1950, to and including February 28, 1951, in those rivers and streams east of the summit of the Cascades, including the Big White Salmon River, and in such waters and at such times as they are open to fishing during the regular summer season; in addition, the waters in Chelan and Okanogan counties shall be open from October 31, 1950, to and including March 31, 1951.

Western Washington—At such times and in such waters as the season is open during the regular summer fishing season and/or the winter fishing season in those rivers and streams west of the summit of the Cascades and west of the Big White Salmon River; in addition, the South Fork of the Skykomish River lying in Snohomish and King counties, and the Tye River and South Fork of the Snoqualmie River in King county shall be open from December 3, 1950, to and including February 28, 1951.

Note: Whitefish catch, size and possession limits are the same as shown below for the regular summer fishing season.

# DAILY CATCH AND POSSESSION LIMITS—Regular summer season:

Not to exceed ten (10) pounds and one (1) game fish, providing the number of fish so taken do not exceed twenty (20) in number, Provided, that the above catch limit shall not contain more than two (2) steelhead over the length of twenty (20) inches. Caution—Daily catch limit and possession limit are the

caution—Daily catch limit and possession limit are the same. One day's catch limit is the total possession limit.

# WEEKLY CATCH LIMIT-Regular summer season:

Not to exceed twenty (20) pounds and two (2) game fish, providing the numbers of fish so taken do not exceed forty (40) in number, Provided, that the above weekly catch limit shall not contain more than four (4) steelhead over twenty (20) inches in length. (The term "week" as used herein shall begin on Sunday morning and end on Saturday at midnight.)

#### SIZE LIMITS-Regular summer season:

Bluegills, Catfish, Crappie, Perch, Sunfish—no size limit. All other game fish—minimum length of six (6) inches, EXCEPT in Siver Lake, Cowlitz county, where ten (10) inches is the minimum length for bass.

# BOAT FISHING UNLAWFUL—Summer season:

It is unlawful to fish from a boat or any other floating device during the summer season in the following waters:

Adams county—Lost Lake

Asotin county-Charlie Lake

Columbia county—Armstrong, Beaver, Blue, Curl and Deer Lakes

Klickitat county—Klickitat River from the Fisher Hill Bridge to its source

FLY FISHING ONLY—It is unlawful for any person to fish for or take game fish in or from the following described waters during the regular summer season by the use of any line, gear, tackle or hook having attached thereto any bait, lure, or weight, except an artificial fly fished in the manner commonly known as fly fishing:

Cowlitz county ...... Kalama River, that part from a point 400 feet above the upper end of the Puget Sound Power and Light Company flume to its source.

Ferry county .....Long Lake

Grant county .......Rainbow Lake
Pend Oreille county...Half Moon Lake, Muskegon Lake and Niles Lake

Skagit county ........Pass Lake

Skagit and Snohomish

counties ..........North Fork of Stillaguamish River Stevens county ......Perkins Lake

BULL FROGS:

Means of Taking: It shall be unlawful to take bull frogs in any other manner than by angling, hand dip netting or

Open Season: It shall be lawful to take bull frogs only at such time and in such waters as are open for the taking of game fish.

Catch Limit: The daily catch limit and possession limit on bull frogs shall be ten (10).

# NOTES ON MEANS OF TAKING GAME FISH:

"Artificial Lights Unlawful"-It is unlawful to fish for game fish in any waters of the state of Washington by the aid of, or use of, any artificial light.

"Juvenile age and bag limit"—It is unlawful for any juvenile over fourteen years of age to fish in any waters restricted to juvenile fishing only. The daily bag and possession limit for fish taken in waters restricted to juvenile fishing only shall not exceed ten (10) fish per day.

"Live Fish for Bait Unlawful"—It is unlawful for any person to use live fish as bait while fishing for game fish or possess live fish with intent to use them as bait while so fishing.

"Feeding Unlawful"-It is unlawful to place or deposit in any waters in the state of Washington any fish eggs, or fish roe or food, or other substance for the purpose of attracting, collecting or feeding fish, EXCEPT in designated lakes shown in individual counties where "feeding" is lawful.

"Multiple Gear Unlawful"—It is unlawful to angle for or Washington by the use of any line, gear, tackle, hook or attraction having or attached thereto more than two spinners, spoons, blades, flashes, or like attractions, and not more than one transparent or black rudder shall be attached to any such gear or tackle, EXCEPT in designated lakes shown in individual counties where any number of flashers may be used.

One line for Fisherman-The operation of more than one line is unlawful.

Two hook maximum—No line may have attached to it more than two hooks or flies, or one plug which may have attached to it any number of hooks.

Closure by all dams-It is unlawful to fish within 400 feet downstream from any man-made dam or other manmade obstruction or in any fishway or fish ladder.

Be careful with Camp Fires, Matches and Cigarettes.
