ARMOR B. MARTIN, an electric and gas utility executive for many years, retired in January of 1964 as Vice President of Washington Water Power Company, Spokane, Washington, after having served in several capacities for that organization since 1953. Prior to that time, he served as Chief Engineer for the Montana Power Company at Butte. Currently, Mr. Martin is Consulting Engineer and General Manager of the Pacific Northwest Power Company. first became associated with the Columbia River Treaty in February of 1960 with the opening of formal negotiations. At that time, Mr. White was Deputy Assistant Secretary of State and he continued as a member of the United States negotiating delegation through the Treaty signatures and the Senate hearings in the early part of 1961. In July 1962, Mr. White was sent to Ottawa as United States Minister to Canada. Following the meeting in the spring of 1963 between President Kennedy and Prime Minister Pearson at Hyannis Port in which agreement was reached to seek a solution to the Columbia problem, Mr. White was designated to head the U.S. negotiating team which, with its Canadian counterpart, concluded the Executive Agreements regarding clarifications of Treaty provisions and the disposition of Canada's entitlement under Article VIII which made possible the exchange of Treaty ratifications. His experience in connection with the Treaty makes him extremely valuable as Moderator of the Panel Discusson on Monday, October 19, during I. E. W. A. 's Thirty-First Annual Meeting in Wenatchee, Washington.

#### DR. HUGH LLEWELLYN KEENLEYSIDE

- Chairman, British Columbia Hydro and Power Authority and Adviser to the Government of British Columbia on Resource Development Policies, Vancouver, B.C.
- DR. HUGH L. KEENLEYSIDE was appointed one of two Chairmen of the British Columbia Hydro and Power Authority in 1962, which organization resulted from the amalgamation of the British Columbia Power Commission and the British Columbia Electric Company, Limited. He has held numerous top official positions in the Canadian Government and has received honorary degrees from a number of Universities in Canada and the United States. Dr. Keenleyside is the author of two books in addition to numerous articles dealing with relations between the United States and Canada and is extremely well-versed on the matter of the completed Treaty.
