If you have not established a contact, looking forward to Grand Coulee's Third Power House, I suggest you do. Some months ago I mentioned to Phil K. that I was mentioning your name in some correspondence I was introducing. I do not think it has borne fruit.

Now I think you should write directly to Commissioner Floyd Dominy, United States Department of the Interior, B_u reau of Reclamation, Washington, D.C., 20240.

Without using my name you should acquaint him with your archictectural and industrial services, stressing your proximity to Grand Coulee and your knowledge of the Northwest.

Right now I am fearful that the Bureau of Reclamation, empowered to develop the Visitor Centers, will tie into some eastern consultants who will be retained beyond their present tenure of Glen Canyon development. But put in your bid at this time or reaffirm it if you have no inside leads. And if Mr. Dominy, as is his wont, take the bit too strong in his deeth, it may be the 1968 elections will change his mind.
