Dear Mr. Relander:

Reference is made to your January 23, 1953 petition made for, by and in behalf of the Wanapum Indians of the State of Washington, protesting issuance of a preliminary permit to Public Utility District No. 2 of Grant County, Ephrata, Washington, for proposed Project No. 2114, to be known as the Priest Rapids project, on the Columbia River.

In view of the Indians' concern that construction of the project may inundate their large burial ground and destroy other remaining evidence of their culture, it should be pointed out that no construction is authorized under a preliminary permit. Such a permit, if issued, would merely give the permittee, during the period of the permit, the right to priority of application for license while the permittee undertakes the necessary studies and examinations, including the preparations of maps and plans, in order to determine the economic feasibility of the proposed project, the means of securing necessary financial arrangements for construction, the market for the project power, and the securing of all other information necessary for inclusion in an application for license.

Should an application for license be filed, you will be advised, and at that time you may recommend special conditions for inclusion in the license for the protection of the Indians.
