## STATEMENT IN SUPPORT OF PROPOSED AMENDMENT TO ARTICLE V, OF THE CONSTITUTION OF THE CONFEDERATED TRIBES:

Article V of the Constitution has not been amended since the adoption of the original Constitution in April 19, 1938. That Article as it was originally adopted and as it is still in force reads as follows:

### ARTICLE V - POWERS AND DUTIES OF THE COUNCIL

Section 1. The Business Council shall have the following powers, subject to any limitations imposed by the Statutes or the Constitution of the United States, and subject to all express restrictions upon such powers contained in this Constitution and attached By-Laws:

- (a) To confer with the Commissioner of Indian Affairs or his representatives and recommend regarding the uses and disposition of tribal property; to protect and preserve the Tribal property, wild life and natural resources of the Confederated Tribes, to cultivate Indian Arts, crafts, and culture; to administer charity, to protect the health, security, and general welfare of the Confederated Tribes.
- (b) To exclude from the restricted lands of the Reservation persons not legally entitled to reside thereon, under ordinances which may also be subject to review by the Secretary of the Interior.
- (c) To recommend and help to regulate the inheritance of real and personal property, other than allotted lands, within the Colville Reservation.
- (d) To regulate the domestic relations of members of the Confederated Tribes.
- (e) To promulgate and enforce ordinances, subject to review by the Secretary of the Interior, which would provide for assessments of license fees upon non-members doing business within the Reservation, or obtaining special rights or privileges, and the same may be applied to members of the Tribes provided such ordinances have been approved by a referendum of the Confederated Tribes.

The amendment to Article V which will be voted upon by the members of the Tribe at the election to be held on May 6, 1961, has been made necessary in the opinion of the Council by opinions of the Solicitor of the Department of the Interior which were announced during the calendar year 1960. The effect of those opinions was to cast grave doubt upon the authority of the Council to perform most of the acts which it has been performing under the provisions of the original Article V since the Constitution was originally adopted. For instance, the Council for a period of many years has been entering into contracts for the sale of millions of dollars of tribal timber. No question has been raised as to the authority of the Council subject to the approval of the Commissioner to enter into those contracts until last year.

The gist of the Solicitor's opinion was to the effect that in order for the Council to act on behalf of the Tribe without a waiver of the Code of Federal Regulations the proposed act must be espressly covered by a provision of the Constitution. There are other examples of the effect of the Solicitor's opinion but this one illustration will serve to illustrate the need and desirability of your adoption of the proposed constitutional amendment.

By your adoption of the proposed amendment you will not be giving or granting to the Council power or authority which it has not previously been exercising in your behalf. The proposed amendment is only a technical one and its only purpose is to clarify the already existing powers of the Council. The proposed amendment reads as follows:

#### ARTICLE V - POWERS AND DUTIES OF THE COUNCIL

- Section 1. The Business Council shall have the following general powers, subject to any limitations imposed by the Statutes or the Constitution of the United States and subject to all express restrictions upon such powers contained in this Constitution and attached by-laws:
- (a) To protect and preserve the tribal property, wild life and natural resources of the Confederated Tribes, to cultivate Indian Arts. crafts, and culture; to administer charity, to protect the health, security, and general welfare of the Confederated Tribes.
- (b) To negotiate and contract with Federal, State, and local governments, and to advise with representatives of the Interior Department on appropriations, projects and legislation that affect the Tribe;
- (c) To employ legal counsel, the choice of counsel and fixing of fees to be subject to the approval of the Secretary of the Interior, or his duly authorized representative;
- (d) To manage all affairs of the Tribe, including the administering of tribal lands, funds, timber, and other resources under appropriate contracts, leases, permits, loans, purchase, or sale agreements;
- (a) To exclude from the restricted lands of the Reservation any persons not legally entitled to reside thereon;
- (f) To provide for assessments of license fees upon non-members doing business within the reservation or obtaining special rights or privileges, subject to the approval of the Commissioner of Indian Affairs, and the same may apply to members of the Tribe if approved by a referendum of the Colville Tribe;
  - (g) To appoint necessary committees;
- (h) To promulgate and enforce ordinances necessary to carry out the powers and duties of the Business Council.

Attached herewith is the Official Election Returns of the Confederated Tribes of the Colville Reservation General Election held on May 9, 1964. The purpose of the election was to elect 7 councilmen to serve on the Colville Business Council. The Business Council is composed of 14 councilmen, representing the 4 districts on the reservation. Representation of the districts are four each from Respelem, Omak and Inchelium and two from Keller. Each year 7 councilmen are elected and serve for a two-year term.

The General Election is conducted similar to County, State and National Elections. The Tribal numbers are afforded the opportunity to vote via absentee ballot. The majority of the Tribos elect their councilmen through General Council thus depriving their general membership from voting by absentee ballot.

Embodied hereunder is a news release we feel is of vital importance to the entire membership of the Colville Confederated Tribes concerning pending legislation, S-1413, before the 89th Congress, 1st Session, relative to the recent hearings held by the Senate Subcommittee on Interior and Insular Affairs at Washington, D. C., on April 5-6, 1965. The bill provides for termination of federal supervision over the property of the Colville Tribes if sanctioned by referendum vote of the adult membership of the tribes. In view of the time element involved we would sincerely appreciate your publishing the article in the next issue of your newspaper.

#### NEWS RELEASE TO TRIBAL MEMBERS

Tribal Members have until APRIL 16, 1965, within which to register their testimony for or against S-1413, new pending before the 89th Congress, 1st Session. Hearings were conducted by the Senate Subcommittee, on Interior and Insular Affairs on April 5-6, 1965, Washington, D. C. The bill prevides for the termination of Federal supervision over the property of the Confederated Tribes of the Colville Reservation, provided that, it is the Wishes of the majority adult members of the Tribe by referendum vote.

Dear Sir:

The question of termination of federal supervision has been pending over the property and affairs of the Confederated Tribes of the Colville Reservation for a period of at least ten years. In recent sessions of Congress the Colville Business Council has consistently requested the introduction of terminal legislation and supported legislation which was thought to conform with the wishes of the members of the Tribes.

However, in the closing days of the 89th Congress, it became apparent that no action would be taken on pending bills before the House Interior and Insular Affairs Committee partly due to a belief held by some members of Congress that it has not been definitely shown that a termination program is in fact desired by a majority of the membership of the Colville Tribes.

In order to properly inform all parties concerned of the attitude of the tribal membership on the issue of termination the Colville Business Council authorized an opinion poll to be conducted among the adult members of the Tribes by its Legislative Committee. It was considered that the key question to be answered by the membership should provide an accurate analysis of the degree to which the membership does or does not desire continuance of communal ownership of the tribal owned assets. Therefore, the general question contained in the poll read as follows:

"Do you favor termination and liquidation of the tribal owned reservation assets at fair value with the proceeds distributed equally to the members of the Tribes?"

The poll was mailed by the tribal office, as certified by the enrollment officer, to 2526 adult tribal members. Of these 122 were returned to the tribal office unclaimed.

A final tabulation of the results of the poll was made on October 31, 1966 by an independent auditor. A total of 1813 polls were returned or 75.46% of those which were received by the members.

Of the 1814 polls tabulated 51 were marked "No opinion".

Of the 1763 who expressed an opinion, 1272 (72.15%) were marked "Yes" in favor of the question on termination. 491 (27.85%)were marked "No" in opposition to the question on termination.

Results of the opinion poll appear to substantiate the position previously taken by the tribal business council that a sizeable majority of the membership favor a termination program of the type formerly supported in Congress by the governing body.

#### NEWS RELEASE

The officers of the Colville Business Council issued a news release today in opposition to Senate Bill No. 478 relating to state jurisdiction over Indians.

The Legislative Committee of the Business Council has recommended that the council take a firm stand in opposition to the bill sponsored by Senators McMillan, Donohue and Herman.

On January 14, 1965, the Colville Tribe requested Governor Evans to issue a proclamation establishing full civil and criminal jurisdiction over the Colville Confederated Tribes. The Governor issued the proclamation effective January 29, 1965.

The tribe has had a two-year period to evaluate the effectiveness of State jurisdiction on the Colville Reservation and are satisfied that this type of jurisdiction is much more efficient than the previous complexity of tribal, federal and partial state jurisdiction.

The majority of the Council members feel that the paramount importance of state civil and criminal jurisdiction is the greater efficiency and effectiveness of law enforcement on the Colville Reservation. This fosters a better attitude of respect for law and order on the Reservation and is especially noticeable in a healthier attitude among the younger generation.

The effect of S.478 will be to repeal the jurisdiction bill under which the state was able to assume civil and criminal jurisdiction on the Colville Reservation. The Colvilles feel that this would throw the Tribe back to living under a condition of complex and confusing law and order jurisdiction. Therefore the Council majority is strongly opposed to passage of this bill.

Before his election Senator McMillan assured the tribe that he would not jeopardize state jurisdiction, but he did not consult with the Tribe before the introduction of S.478.
