REGIONAL ADMINISTRATOR FARM SECURITY ADMINISTRATION DUFFY OF PORTLAND IN AN ASSOCIATED PRESS RELEASE YESTERDAY DECLARED QUOTE AN ORGANIZED MINORITY HAD VIGOROUSLY OPPOSED THE CAMP UNQUOTE. DUFFY SEEMS TO BE LABORING UNDER SOME MISAPPREHENSION INASMUCH AS STRONG RESOLUTIONS OPPOSING A FEDERAL MIGRATORY LABOR CAMP IN YAKIMA COUNTY HAVE BEEN ADOPTED BY FIFTEEN GRANGES, TWO POMONA GRANGES, THE AMERICAN LEGION, THE AMERICAN LEGION AUXILLIARY, THE WASHINGTON STATE HORTICULTURAL ASSOCIATION, THE BOARD OF DIRECTORS OF SCHOOL DISTRICT NUMBER SEVEN, THE SCHOOL DISTRICT BOARD AT UNION GAP IN PROXIMITY TO THE LOCATION OF THE CAMP, FARM ORGANIZATIONS AND NUMEROUS INDIVIDUALS HAVE AS WELL PROTESTED; AND IN ADDITION THE SENIOR AND JUNIOR CHAMBERS OF COMMERCE AND SEVERAL SERVICE CLUBS, OF WHICH YOU ARE AWARE. MOREOVER, THE BOARD OF COUNTY COMMISSIONERS HAS PUBLICLY STATED THAT NO OFFICIAL REQUEST HAS BEEN MADE OF ANY GOVERNMENTAL AGENCY TO ESTABLISH A CAMP IN YAKIMA VALLEY. CONSEQUENTLY WE VIGOROUSLY PROTEST THE STATEMENT PUBLICLY MADE BY MR. DUFFY WHICH IS ENTIRELY MISLEADING. Unless otherwise indicated on its face, this is an unrepeated message and paid for as such, in consideration whereof it is agreed between the sender of the message and this company as follows:

1. 2.
