COMMISSION AWARDS CONTRACT FOR STUDY OF TIMBER POLICIES

Representative Wayne N. Aspinall (D-Colo.), Chairman of the Public Land Law Review Commission, announced today that George Banzhaf & Company of Milwaukee, Wisconsin has been awarded a contract by the Commission to study "Timber Policies on the Public Lands".

According to terms of the contract, the firm will perform the study at a price not to exceed \$199,400. The final report is due March 31, 1969.

Milton A. Pearl, Commission Director, reported that Banzhaf & Company was chosen from among 23 prospective contractors who were invited to submit proposals. The firm, organized in 1939, has specialized in the field of timber resources and forest products, including forest resource analyses and studies of woodland organizations. Project administrator will be George Banzhaf, head of the organization, who has been in consulting work since 1924. Among other objectives, the study will:

The Commission's study program will cover 34 subjects comprised of all aspects of public land management and resource use. On completion of the studies, the Commission will recommend disposal and retention policies designed to enable the general public to realize the maximum benefit from its public lands.
