Castings will be poured in December and that and January will be given over to assembling them, welding, fitting etc. sand blasting to remove the "investment," or the cast into which the bronze is poured. This, because of chemical reaction, heat etc. crumbles and becomes almost powder, hence the term pere due or last wax process.

The patina work will follow in late January and will take four or five days Papaleo is the onlyone who can do this at the art dept. It is done with acids, water and a bunson burner type of blow torch. But more on this in my detailed explanatory writing of processes, later.

Hopethings are going well with Quigley's part, the construction etc. I plan to finish off the Sun, Moon and Star this week, and that I can get two casts from a straight plaster cast, which they would never think of attempting at Pico, as good as they are.

Hope the pictures give you and others at the PUD a "starter" insight. And hope to see you soon.

I am sending it because it contains several pictures of Tommy Thompson, (Chief Kuni), one of the head, sculptured after the pictures in the book were taken. It will give you and the others a basis for comparison with the individual.

Celilo Falls is some 150 miles downstream on the Columbia from Wanapum Dam. The falls are covered now by a man_made lake, created by the Dalles Dam. Tommy thompson is dead.

After you people have looked it over you can dispose of the book as you wish. Inasmuch as it is a juvenile, perhaps you will want to take it home to Debra. I saw Henry Thompson, pretty old himself now, the chief's son the other night at big Indian Council. He and Flora, the chief's widow, will come to the "unveiling" of the heads, which will have to be a kind of religious ceremony in advance of them being put on disphay. The widow will "bring out" the dead chief's headdress, costume etc. and exhibit it publicly. The little girl, Linda, is now 14 and goes to high school at The Dalles. I'll have to get the PUD to provide a feast for the Indians who will all be
