

Emmons, the present Commissioner of Indian Affairs has written the foreward to the book. Incidentally Mr. Emmons was in Spokane about four or five weeks ago. I made plans to travel there and hear his address before the 12th annual Congress of American Indians but the last minute an emergency arose which took me to Ephrata to operate. I did call him by phone. On my next opportunity to drop him a note I shall slip in one of your fillers on the "Drummers and Dreamers."

I had to go to the hospital in Soap Lake today and stopped in SYNDER'S at Ephrata. I talked with Mr. Snyder who will stock your book but I also told him you will be contacting him before publication.

Yes I have other plans for many things I'd like to write. But that seems as far as I can get with it lately, plans, all in my mind. My basement is littered with personal papers from Pine Ridge, bulletings, notes etc. that my wife and I were going to sort and start on another book of personal experiences with the Oglalas but I've not had the time. Dear Mr. Relander:

Thanks a million for the publication from the Univ. of Wyo. with the article "The Peyote Culture Among Wyoming Indians" by Molly Peacock Stenberg. Do you recall the title page (opposite page 84) for her article. It reads, "A Transitional Link Between an Indigenous Culture And an Imposed Culture." This thrills me for this reason: I arrived at the same conclusion, independent of having seen her article, for this is the first time I've seen it and independent of articles with such a thesis if there are others. It is always nice to know that others finds similar ideas. Her idea is carried throughout her article. With the Sioux and other tribes the Ghost Dance was suppressed. The Ghost Dance was an expression for their beliefs, ideas and salvation. The Peyote Cult has taken its place. As the Indian becomes more 'non-Indian' his beliefs change and the Peyote cult is a 'step higher', that is away from their original religion.

I found nothing in her article to disagree with. You will notice she writes of what I spoke to you about. Peyote is not really a narcotic. It is not the awful thing some groups of people would have one believe simply because they want the practice stopped.

There is one error in my book. I stated that the users of peyote do not hallucinate. Idid not intend to say this. The not was purely a typographical error for I knew different. But it was in the original manuscript that way because I checked the carbon. So it was my error, not the publishers. And reading the profifs I didnt pick this up.

And thank you for the issue of TRUE WEST. The article on the Wounded Knee Battle I did not like. I know John Nelson from Pine Ridge when I was there. What a poor representation of John's words to begin with because John didnt talk anything like that. Knowing John but not Mr. Marvin Almon who writes John's story all I can say is Mr. Almon put words in John's man th if they werent his (Almon'S) own fabrication. The most wiend part to me is when he says Chief Big Foot was the last to be searched for weapons. He makes it sound that Big Foot was a sinister appearing man all wrapped in a white robe with only his face showing, that he suddenly disrobes and pulls a knife on a half-breed interpreter. I feel sure after the great amount of reading I did on it - though to be sure I was far from exhausting the research material by a long long shot - that this is pure non-sense. Incidentally I have negatives of all the old pictures of Wounded Knee that are printed in the magazine.

I presume that you get "The Westerners - New York Posse Brand Book." I have volume two, number three in which reference is made to your adopting a tribe - the Wanapums. If you do not have this I will send it to you. We were discussing Mari Sando, when you were here. I see she is on the publication committee for this publication. It also lists her Old Jules which is being published again.

Thanks again very very much for the two publications you sent.

I must say I've talked to Judge Brown on a number of occasions. I believe however that you have him sized up right. Now his book, the material in it may be good, accurate. That I dont know. But I've been impressed with oral interviews with him as you have from the mWDW interview. I know that his book is covering all Indian phases in Wash Terri for the years mentioned. I've heard that because it was so long I think Caxton refused it since he would not revise or cut it. He is having it printed by Shaw Borden in Spokane and Jerry Peltier of the Old Book Store, Clarke's Old Book Store, I guess it is called will be the outlet. I plan to get a copy when it appears. Thanks for clipping on MASONS REACH NEW MILEPOST IN YAKIMA VALLEY HISTORY.

Thanks for offering to scan your microfilm for me. Well here is something. I make notes rapidly and something bothers me when I cant get to the source of something. I've made a note of Lt. Abercrombie having some trouble, it concerns Moses and occured in April of 1883 and I cant run down the situation and it escapes my memory. Are you also a magician? Then perhaps you can set my mind to rest.

(More about the Judge Brown thing. Sometimes it is difficult when talking to Indians as you well know what the true family relationship is between individuals because of misunderstand of both whites and Indians of terms. For instance Chillileetsa, or Jim who is Moses nephew, (one/marker dedicated to his mother, a sister to Moses) is often called Moses son in print. A brother is used for close relatives not brothers used in the sense the whites use the term.)

Did you ever get any information from any Indians as to Moses spirit power? From what animal did it come?

Who is A.J. Cain of Waitsburg? I have a letter from the war department xxxxixx it was written by Cain in Jan , 14, 1879 and in it We-at-ta-ta-tum.relative of Moses visits him in Waitsburg and reports after the Priests Rapids Conncil with Howard and again after Moses capture explaining Indians not on warpath etc. Who is Cain?

Forgive me, but would you once again give me the Wanapum spelling/for the Moses band? My notes written the other night in car are far from clear. meaning munderers.

I'm headed for Spokane this coming weekend to do some work in the district court records of a trail at which Moses testified concerning the selling of whiskey to Indians by a white ferry owner at Port Columbia. Hope to go over a couple of manuscripts in the library at Cheney as well.

Hold your hat! In about another month after I finish copying stuff and get down to some concentrated study I'll have loads of questions to ask you.

Indicate the pictures of Moses you want and I'll have copy negatives to you in a flash. I have a good source, good photographer for that.

Will I need any special pre arranged authorization to go through the Streamer papers in Tacoma in January or will I be allowed to view them on request when I visit there at the His. Soc?

In 1878 in Dec. Wilbur requested troops from Howard for the Yakima area. Howard in his book MY LIFE AMONG THE HOSTILEStst says he placed a good camp in Kittitas valley. This is on page 362. I know there were troops in Kittitas valley in 1879 when Moses returned and from W sh and they had their big council at Wenatchee. But the troops that Howard sent in Dec. 1878 went to the Yakima reserve did they not because Wilbur in one letter writes that he found them camping in the snow and cold and invited them to come up to the headquarters buildings and live around there until after cold.

Howard took troops or sent troops to White Bluffs during hunting of Moses in Dec '78 but there was never a camp near White Bluffs was there?

In the Spokane Evening R view for July 2, 1885 page 3 is an article that Troop L, 2nd Cavalry from Fort Coeur D'alene, Captain R. Norwood commanding passed through the city (Spokane falls) this am on road for Moses Reserve. They will put in 2 or 3 months of detached service, force numbers 53 troopers, withthree x 6 mule forage wagons and the usual number of teamsters. Click, why did they go over there. Whey didnt troops go from Fort Spokane if needed. And when they say Moses Reserve does it mean the Columbia Reserve or around Nespelem where Moses was then?

Click, I wrote to the National Archives for some information about Moses being run across the river from Yakima territory in 1878. This, the enclosed copy is the reply I got. Would you have any of the information in here in on your microfilm?

You wouldn't have any copies of what I take to be Yakima newspapers would you? For 1878. Those are all burned are they not?

Tribes of Middle Columbia Salish.

1. Columbias

2. Wenachi

They were called Priests' Rapids people by early fur-traders and also Rock Island People by early furtraders. Traders and whites used the names Sinkiuse and Sincayuse and Columbia Cayuse in distinction to the Cayuse tribe (Waiilatpaun) who were some times called Neg Perce Cayuse.

Wenatchi-were of Yakima originx probably from Winatcha meaning in Yakima river issuing from a canyon.

Names Pisquous and variations used for Wenatchi.

Page 92 Shahaptian tribe: Palous, Yakima, Klickitat, Walla Walla, Umatilla and Nez Perce.

Page 93

Middle Columbia language more closely related to Okanogan than other Salish tribes.

Moses Columbia Salish occupied Columbia on both sides from a little distance below mouth of Wenatchee River, About Cabinet Rapids which is below Rock Island, to a little below Priest Rapids "and in former days down to near The Dalles," adjoining plateau east of river karders from confines Sanpoil, south along borders Spokane to Palous country near Snake and possibly in former days to boundaries of Nez Perce.

Wenachi tribe from here north to half way between mouths of Methow and Okanogan.

Some of Columbia divisions or bands of former days were

1. Those of Umatilla valley

2. Those at mouth of lower part of Yakima River, in Columbia valley some distance above and below.

3. Those with headquarters at White Bluffs

4. Those of Priests Rapids and nabor hood of Columbia valley and east side of Columbia Chief Moses "---was the best known and most celebrated chief in his time in eastern Washington. He was over six feet tall, very straight and weighed in later life, when he had become rather stout, about three hundred pounds." Moses washer was Skatelkoo

Mr. McCrossen, former agent at Nespilem knew both Moses and Joseph and thought Moses greater of two, wielding more power among Indians, his words receiving more attention.

Page 97

Early part of Columbias absorbed into Yakima tribe. One time population of Columbias very numberous. "Once the largest of tribes." reduced by wars and disease. Small pox epidemics and other epidemics four times; small pox about 1800, many deaths according to flathead Indians came via way of Crow Indian. Smallpox then in 1825, swept away great numbers. About 1830-32 a pestilence depopulating whole villages brought up Columbia by ship. 1847 measels, this time killed lots Spokane Indians.

Prior to epidemics in 1700s then Columbias made up of populous groups all along Columbia.

Movements of other tribes.

Shahaptian people, later called Yakimas, moved thru Dalles and up and down Yakima valley. Yakima movement believed to have occured 250 years ago now. Proceeded to White Bluffs taking over this territory, Then Palouse country and becoming known as Palous Indians. This is believed to be earliest movement into Columbia territory. A second invasion of some kind of people about same time passed into hills north of Columbia and east of Dalles from Cascades to Horse Heaven and became known as Klickitats. There became great inter mediates with Columbias and costal Indians for trade.

Another smaller invasion up to Columbia of other tribes.

Also early movement Cayuse pushed down the Umatilla on Columbia but did not cross it. Snakes moved up from south east, from 1800 to 1830. Hardly any tribe lived south side of Columbia from The Dalles to Umatilla because of raiding parties of Snakes.

"Moses Columbia informants assert positively that their tribe extended much farther south and west at one time, seemingly in the middle of the eighteenth century, and that they occupied the valley of the Columbia down to n ar the Dalles, where they came in constact with Wishram, Wasco, and a Salish tribe said to have spokane a language xmisimilar to Thompson, and which they called by the same name x as the Thompson River tribe of the north."

Bows made of Juniper, Syringa, Flat bow most common; double curved bow used; sinew backed and covered with snake skin.

Columbias began regular journeys to country of Flatheads to join then in buffalo hunts after beginning of last century.

Moses Couldd, Grand Coulee and Moses Lake favorite camping places, with M ses Lake as a favorite resort for obtaining eggs, ducks and geese.

Page 119

Sal on dried in wind, some oil put up in fish-skin bottles. Calmon caches lined with grass and bark.

Page 120

Used pole-rafts before canoes were plentiful

Horses—As late as 1830 some Columbias families did not have horses while some chiefs had big bands horses. Bands ran wild on plateau east of Columbia. Owners remunerated members of Moses Columbia for running, driving and corraling the wild horses. Yakima tribe always trying to steal horses from Columbias, so Columbias kept watch out of young men on plateau to watch for theeves.

Large numbers corralæed before going on buffalo hunts, Chief Moses father had from 500 to 1000 horses accounts given to Teit vary.

Horses came to Columbias via way of two sources, the Cayuse Walla Walla and the Spokanes.

On rare occasions Mez Perce attacked Columbias. And Columbias went to Nez Perce.

During last century wars were held with Yakimas, but very small affairs against horse thieves.

Kweetcha (Blue Robe) had scars of fighting in party against Yakima's who had stolen his father's horses. (Blue Robe brother of Chief Moses) Blue Robe recapured some horses and killed two Yakimas.

Favorite summer rendezvous for horse racing and playing game was at Moses Lake. In later days Umatilla and Spokane went there to meet the Columbia

Smoking ceremonies were invogue.

Kinnikinick was bearberry leaves and red-willow bark.

Winters my interpreter and xx one of the Reservation Indians and went 27 miles with said part to meet Chief Moses and his part at Said Ferry, to prevent if possible his arrest, and to hasten his departure to Washington."

I'd like to see you type 180 words a minute. I used to do about 100, havent timed myself lately but I make so many mistakes. I can always decipment what I write usually. Thanks for help. I'll return this clip ing at once. Sincerely, P.S. I have been as ocided with the Colvilles for about 7 years now. My first meeting with people like Billy Curlew, Harry Namampkin and Kamiakin Cleveland I was impressed that they did not say Moses, but Moshush. I have thought about it MANY times. Then you were the first person ever to make any remark to me about it and it fired my curiosity more. Now I've not been to the reserve since then to talk to the Indians about it and see if I can find the meaning. But I ran across something at Cheney at EWCE in the Hargreaves Library. There is a manuscript by Andrew D. Panbrum and he writes on page 201 I think it is of the manuscript "Mushushe (now Moses) being cousins to the Josephs, naturally sympahized with them ---- The above parenthesis are not mine, they are the authors. This immediately fired interest. So I'm going to keep on it. He also explains this cousin business-Nez Perces marrying Columbias make Moses and Joseph cousins, not in the sense we think of cousins. I remember Judge Brown giving me a long winded story about Moses coming to Moses, the name from Montana. I hate to be as sticky as an old fly in the autumn on this ferry business. But in the information you loaned me is a letter from Ft. Simcoe written Dec. 4, 1878 from Wilbur to Pete Nelson to pay for ferrying goods. Now I know and am positive Pete Nelson ran ax Ferry at The Dalles. But is it possible a Pete Pelson, a different Pelson ran a fy over Yakima. Does Mrs. Tippie have anything to say on this. I ask this only not to miss any chances. But between Yakima City (Union Gap) and Ft. Simcoe one does not have to take a fy, nor did then anyway.

In the Wilbur letters you loaned me, letter 76 written Dec. 17, 1878 from White Bluffs to Wilbur, there is no signature nor indication who wrote this. Do you have this on microfilm? Can you tell me who wrote it?

This information I have mentions Sheriff Schnebly from Kittitas. Was Yakima and Kittias county secarated in 1878 and 1879? What I wondered was there another sheriff at Yakima City in 1878 and 79? I checked my last letter to you, on the Moshush stuff here is one more item from Pambrun's manuscript at Hargraves L b. at Cheney. This is also fro page 201 "The Piutes or Snakes being now subjugated General Howard turneds his attention to Moses. Moses was not the individual's name, his proper name was Mushushes. Moses another Indian was the real chief of the upper Columbia Indians, he was a civilized Indian, self supporting and peaceable therefore ignored." Certainly Moses, was the one about whom we write was not ignored so that he can not be one referred to in Pambrun's manuscript.

I'm returning Dean Gui's BUGLES IN THE VALLEY. Thank you very much. Do you have any personal knowledge or printed documents indicating how the buildings werek kept or used when BIA took them over and Wilbur in charge? I wonder if Wilbur used the Guard house the troops had built for a guard house as well? Could it have been in the same building that he put Moses?

I hope sometime in latter part of Dec. to make a trip to Yakima.

What I would like to do is make parts of the book 'live' if possible by mentioning some thing familiar about the jail, placement of window say, as an example only, what Moses saw when he looked out. Or how far guard house was from Agents house or office, was it across the parade ground. I dont want to write about the Yakima ggency but I want to make the surroundings familiar and alive only so far as Moses is concerned. Dont faint if this offends you, but there are parts to Sandoz's books that to me place me right there with the Indians. There are those who do not like Mærie Sandoz books so what ever your thinking is on them I dont know. Well I probably still have not got my point across.

I think Mr. Brown will get the McCellan papers.

Thankryou for the wonderful article on Vantage. I do mean wonderful. I have a great interest in travel, historically speaking and I learned a great deal from this article and I found it most stimulating and informative. Your picture of the ferry however is not the KITTY-GRANT. The picture you have is the EVERYDAY ferry which ran at Maryhill and this particular picture was taken at Maryhill. The EVERYDAY later ran at Cathlamet when it was sold to ferry interests there but the ferry was then remodled and did not look much like its former self. I can find no instance in which the EVERYDAY ferry ran at Vantage even to help out. This particular scene is Maryhill and not Cathlamet because the approach is Maryhill. When the KITTY*GRANT ran at Vantage a concrete slip was made all down the shore line on each side. This way no landing platform had to be moved for changes in water level. Those concrete forms are still down there. I have lots pictures of the KITTY-GRANT and a couple of the EVERYDAY fy before being remodled and quite a number after it was remodleded.

Click would you please send me a glossy picture of the picture which appeared with your article. Please also send me a bill for the picture.

The KITTY-GRANT was a side wheeler and looked much like this but if you like I will bring some of my pictures to Yakima when I come visit you and show you the difference in the boats.

You are a truly gifted person. You have a REAL talent havent you? Pardon me for being so enthusiastic but when I saw the photograph of Moses I was thrilled. How wonderful. How satisfying. Wonderful. Amazing.

Would it be too much to perhaps think along the line of using a photograph like that for the dust jacket of our book?

Click here I go again. I was always under the impression, and it appears in print lots. Camp Harney near old Fort Colville, was closed, moved to Lake Chelan in 1879 to ge there to guard Moses. It camped winter at Foster Creek, spent summer 1880 at the Lake, but then moved that fall without spending winter there, to Fort Spokane. Judge Brown told me once there never was a fort Covlille, officially, listed as such by the army. Was always Camp Harney. If this is the case were troops sent to to Lake Chelan from the Kittitas camp near We-nan-am creek? Was that camp busted up soon after the summer 1879?

I'm not writing about the troops - but feel a certain amount of this is necessary for understanding. I think the movement of troops to Lake Chelan is important beccause they were sent there to keep an eye on Moses' people.

Incidentally what creek is We-nan-am in the Kittitas walley?

Have you ever been told by any Indian where in the Kittitas valley Moses and his people camped. You know for the years 1880 thru 1884 they spent a good deal wt of time living in Kittitas. The folks in the Kittitas were kinder to them than those in the Yakima valley.

Brewster is in the neighborhood of town or post office called Swansea, then Virginia City. The name Brewster is a phonetic spelling of a man Bruster who lived there. Now is this what you want? Can you ask me specific questions?

I work on Moses nearly every day. We have divided the work (Brown and I) on what each of us will do. I have about 300 pages typewritten and have another to go on a first draft of narration from my notes. Incidentally the first loc tion fur post was tract 37, lot 9 sec 17 Twp 30 NR 25 EWM and later location was lot 7 sec 21, Twp 30 N Range 25 EWM.

Klahum, see Meaney's book "Origin of Wash. Geo. Names" for this. Same for Olema.

Ophir, town on Okanogan river north of Brewster some ways, distance ??

Present Brewster was called/a number of names before because Brewster. Incidentally the name Brewster is a mis-spelling of an early homesteader there who was Bruster. Community called Swansea, and Virginia Bills for Wm. Covington, and Virginia City. Then post office Brewster so named in 1898. Bruster was John Bruster.

Lake behind Chief Joseph's dam called Lake Rufus Woods. Or is it Lake Woods?

Alma was first name present town Okanogan.

Ives Landing, first name Pateros. Named for Lee Ives who ran trading post there.

I have lots stuff like BARRIER river for Methow, but this stuff in Meany's book I wont receat.

Pateros named 1900 by Lt. Nosler who bought the place. Name same as one in Phillipines for which he named town.

Lake Alta named for Alta Warren. She married a Mr. Hines. I've seen this as Hynes also.

Cooper's Rapids, just below mouth Methow river.

Zena, a rail station on right side Columbia below Pateros. On left side river across from near Zena was Bonita.

Azwell post office opened 1919 and closed 1998x 1958.

Bonita named by Lt. Edward Nosler as well for name from Philippines.

McNeil Canyon/comes down co Columbia to Chelan Landing. This is above the mouth of the Chelan River as Chelan Falls is below the mouth of that river on the right bank.

Names for Click -2-

Camp Chelan, established up at end lake by army in 1880. It was the army which named and used Chelan Landing on processed route from Sprague which would be a sup ly point when the rail line would be completed in 1883.

Chelan post office established 1890.

Chelan Buttte, the high peack to south side end Lake. Called *** Yill-i-min by Indians neaing singing mountain. They'd listens for wind to come down announcing a chinook.

Howard Flat - the flat north of Chelan (not the bar at the river) but the first bench below above the river. On it is a single rock sentinel called THE WART by early homesteaders and Knoc-ho-lous by Indians.

Winesap - a rail station on right xide bank river below Knapp's Hill where road leaves river and goes up over hills toward & Lakeside and Chelan.

Navarre coullee was called Wells coulee first by early settlers.

Goose Tail Rock - (partially Underwater I would guess since lake up behind Rocky Reach Dam.) Was at foot of Knapp's hill.

Lake Entiat, water behind Rocky Reach Dam.

Bray's Landing a steam ship landing on left bank river across from Winesap. Brays is slightly down stream from across from Winesap. Brays is in Sec. 28, T 26, R 21.

Corbaley Canmon in Doug. Co runs down and opens at Orondo. Name for homesteader, who was Platt M. Corbaley who settled up at head of the canyon.

Spencer Canyon first canyon below mouth Entiat River, and across river on right bank from Orondo.

Of course Waterville, Badger Mountain. And towns up the Entiat, Methow and Okanogan river.

Columbia Valley - I'm not real sure but take it to mean area below Orondo on left bank before reach sandy part river bank agross and up from Wenatchee.

Crum's Landing, shore opposite Orondo, am named for ferryman here before 1900. I dont know his first name.

Sunset Highway runs into Orondo from Spokane, completed in 1915.

Fisher's Landing the name of Orondo before was/Orondo by J.B.Smith. Never post office of Fisher's Landing.

Pine Canyon runs into Corbaley canyon in upper part.

Shinn Flats are east of Rock Island, on ea t side Col mbia.

Stemelt creek is below Wenatchee, and below Squillchuck where Moses brother was killed.

On right bank of Columbia above the wenatchee river, north is Burch Mountain and south or below Wenatchee river at mouth is Sunnyslope, an area.

Wheeler Hill - this is below town Wenatchee and Click I'm not sure if it is north or south of the mouth of the Squillchuch but I think to the souths side.

The Nanum trail over the Wenatchee Mtns. Also there is a Naham! I'm not sure spelling.
