Major G.O. Haller, Comdy Expedition for Boise. Received Fort Dalles May 25,1855.

In the letter of instructions communicated to you by the comdy officer of this district under date of June 21st ,'55 in reference to your operations against the Snake Boise Indians the following paragraph occurs:" forward report by express as opportunity of your operations from time to timeat least once a month, or in case of any trouble or of need oftener."

I am directed to inform you that up to this date no official report has been received from you although your command has been six weeks in the field. Private advices have been received however up to a late date and important information has been received in reference to your movements by other than official channel. The comdy officer directs me to express his regret that while private letters have been written by you no communication have been received in reference to the duties with which you have been instructed.

He desires you to submit in writing a statement of the causes which have prevented you from complying with the spirit of the instructions furnished you in reference to corres ondence and directive for the future that you avail yourself of every opportunity to keep him thoroughly informed of your movement. Sir : Your reports of July 17th and two of July 21st have been received.

The general commanding is glad to learn that you found the AMEXICAN ammunition left at Fort Boise in safety.

We have no entered the country of our enemies the Snake
Indians a barbarous and treacherous people and therefore the utmost vigilance
and caution is required to guard against a surprise or the loss of animals.

This command exclusive of the sick and those excused from details will be divided into five detachment for guard service only, each as far as practicable to be composed of members of the same company who will

alternately do necessary guard duty.

Each detachment during its tour will be under the command of the officer of the day . The tour will commence when on the march in the morning as the advance guard when the officer of the day with his guard will proceed the command at a considerable distance to recointer the road carefully exam inining the road for indications of the presence of Indians to select if necessary suitable planesto encamp at the distance which will be prescribed and to throw out scouts, some distance in advance of the campany ground to observe from eminences if practicable if there be any indications of an enemy. The scouts will remain out (7 letters undecipherable) if possible to observe the approaches until the camp guard has arrived in camp the darkness prevents further observation . The advance guard will compose the camp guard horse guard with the addition of four quarter master men during the night and a rear guard on the following day. When not en route the tour will commence in the evening and terminate the following evening. The advance guard will habitually march wth a non com'd officer and file of men in advance, say one hundred yards of the main party.

The fire arms of the command will be left loaded and at all times ready for service. There will be daily an inspection of the arms before sunset.

Private Roger Crayton of X.3 Co. an arty. and Private William Wilson and Maurice Moore of I Co. 4th Infy are selected as a pioneer party who with the burler will be on duty with the head quarters

the Snake Indian prisoners will hereafter be strictly guarded. They will be placed in charge of the camp guard by night and day when en route they will march with the rear guard. The non com'd officer comdy the camp guard will during his tour be held accountable for the safety and proper treatment of the primarrs captives. Information has been given of gross abuse being practiced on these unfortunate people and it is announced that the most summary punishment will follow the repetition of any abuse.

In case of any alarm the train will close up and to the right so as to give place in the road for any movement of troops or express men. In case of an attack it will be most probably be firing from a great distance and from a height in which case the officers in command, either in front or return rear nearest the enemy will detach a small party of skirmishers to EXEMPTED in their fire and drive them off. The main body of the troops if not under the fire will place themselves in close order and await orders. The A.A. Q.M. will give the necessary orders to his men in order to prevent stampedes in his train during the firing.

The attention paid to the animals and their respective duties deserves commendation and they have my sincere thanks.

It is assured here that by the time this letter will reach you, your command will be on the ground designated. You are authorized to expend twenty rounds of ball cartridges per man at target practice taking note of these shots and the names of the men who may excel.

All the parties which may arrive at yo r depot will be consolidated. As they all belong to Capt. Russell's company. You will please inspect their arms, clothing, knapsacks, canteens, ammunition etc. and report as early as practicable what may be unserviceable or required for the men with you as as to be efficiently equipped for the field service.

Capt. Russell will arrange so as to get two dark blue shirts and a winder hard brimmed black hat for each soldier. These will furnish the men with a sufficiency of flannel shirts and caps.

Sergt. Van Name of I Co. with six privates and a pack train will report to you and deliver this letter. His party is rationed to include the loth instant. The time to include which your command has therefore been rationed. Twenty days rations for forty six men. These were taken with you some extra rations (about 50) which it is expected will ration the packers that went up with you.

I have taken possession of seven long range rifles found in the box containing a musket and turned them over to Lieut Day 3rd Artillery. The musket, a bayonet, bayonet scabbard and frog, musket waist belt and plate of yours I have delivered to Pvt M. Cooper of I Company. I have loaned him a cartridge box and a screw driver belonging to I company 4th Infy which you will please return as soon as practicable.
