The Seattle man who prepared the pamphlet on the forts of Washington is Mr. J. S. Whiting. We have several old Simcoe photographs including the biolinese, the ruins of the Indian school, groups of employees and children, Captain Priestley and family at the agency house, and Captain Priestley and Chief White Swan. I presume you have seen the rotogravure section of the Seattle Daily Times for December 17, 1939. This section contains illustrations of the blockhouse, the commanding officer's home, part of the living room of the commanding officer's home, and the porch of the headquarters building. Our Pacific Northwest Collection also includes a number of newspaper clippings and periodical articles relating to Fort Simcoe. These are all available to you on loan through your nearest public library. I am sorry to report that I have no illustration of Fort Na-Chess. Mr. Todd has asked me to reply to your October 21st letter regarding Samuel Hill.

Perhaps I should commence with the photographs which you require. I have not been able to find photographs of the actual construction of Stonehenge but the <u>Seattle Times Pictorial Section</u> for March 18, 1962 carried a number of photographs of Stonehenge, near Maryhill. You could order prints from the Photo Department of the <u>Seattle Times</u> by giving the date. Page 4 carries a photograph of the outer circle and of the interior showing the "altar" stone with the plaque bearing the names of the Klickitat County First World War dead. The <u>Times</u> for November 7, 1926 carried photographs of Queen Marie during her visit, one includes Mr. Hill.

This library has a photograph of the Hill residence, 814 E. Highland Drive as it appeared in 1910, made by Asahel Curtis and for it our catalog number is 17656. Our photocopy can reproduce it for you. The Seattle Times carried a photograph of the residence on October 25th, 1932, the building then covered with vines. The Seattle Public Library has a photograph made in 1953 by Mr. Werner Lenggenhager, 1631 Belmont Avenue, Seattle. The outside seems unchanged except that it was not vine covered.

We would not have a record of the bill of sale, it might be obtained from the King County assessors office, but I can cite newspaper items concerning the sale of the residence to Mr. and Mrs. Theodore Plestcheeff who planned to convert it to a duplex. The Plestcheeffs still live at 814 E. Highland Drive, and Mrs. Emma B. Stimson is also listed in the City Directory at the same address.

Our Photocopy Service can supply inexpensive copies of these clippings for you. The <u>Times</u> article for October 25, 1932 announces that the home is for sale and gives a description of Mr. Hill's home life as a semi-recluse, alone except

for servants. The Times for February 23, 1937 announces the sale of the house, tells of the Plestcheeff's plan, and describes the home furnishings.

Biographical articles give Mr. Hill's residence as Maryhill, and there is no mention of Mrs. Hill having any part in Seattle's affairs although Mr. Hill belonged to several Seattle clubs. Clarence Bagley has a 5 1/2 - page biography of Samuel Hill with portrait, in his 1929 History of King County, Washington, volume 2, pages 114-121.

For any copying, please write to Miss Doris L. Payne, Photocopy Service, Room 450, University of Washington Library, Seattle 98105. She will reproduce the material, and bill you collect.
