County Library Prepares

Organization is well under way for a rural library in Yakima county, Operating under a 1941 amendment to the state library law, a board of five trustees has been appointed by the Yakima county commissioners. The board has outlined the framework of the rural library system to function county-wide in unincorporated areas.

The county library this year is financed by a grant of \$1800 from the state library fund, plus an additional \$10,000 from sale of 2 per cent coupon warrants. These warrants will be retired during the next six years out of the annual county library revenues from a 2-mill levy on property in unincorporated areas. It is estimated that this levy will produce about \$51,000 for the 1946 county library budget. Added to this tax money will be \$3500 from the state library fund, for a total budget of \$55,000.

The county library will offer three types of service: Branch libraries will be established in the larger unincorporated towns; smaller station libraries are to be located at popular rural cross roads (such as Kiles Korner on the White Swan road); a bookmobile will circulate among communities not served by a station or branch.

The county library is circulating about 2000 volumes now. The board has on order and expects to use 10,000 to 15,000 books by the first of next year. Each locality will have a supply of books, depending upon the population-the books to be changed every month to make the whole pool available to all the people at one time or another.

The rural library idea has been accepted in many others of the nation's 3000 counties. It will be well used here.

Miss Carol Trimble Takes County Post

Miss Carol Trimble, head ilbra-rian at Yakima High school, has been appointed to the post of Yakima county librarian, George M. Martin, chairman of the re-cently formed county library board, announced yesterday. Permanent quarters for the county library organization of

Permanent quarters for the county library, organization of which was approved by voters of the county at the general election last fall, have not yet been obtained, but will be established within a few days, Martin said. A headquarters separate from the headquarters separate from the Yakima city library will be developed.
