Sir: I have the honor to report that the general excitement caused by the occurrence of the 6th instant which re ulted in the death of Sergeant Stroble of Company I. Second avalry, California Volunteers has to a great degree subsided. Ex-overnor Weller and Downey addressed their rebel friends in this place, guaranteeing to them their protection in the event of their election, of which they assured them there was no doubt. Their address didnot serve to allay the excitement but rather increased it. The news that this camp is to be reenforced by two companies and also that Port Miller is to be reoccupied has had a beneficial influence upon the moral conduct of rebels generally. I am satisfied that an attack upon this camp was planned receiving aid from Fresno and above. James Wells, the principal actor in the affray on the 6th has not yet been a rrested. His friendswill not give him up to the civil authorities upon the corditions as telegraphed to you. They of course allege that they know nothing of him. I am satisfied that he is yet in Fresno County. The testimony in thecases of prisoners Gordon Douglass and Robert Henderson will be taken as soon as all is quiet and forwarded to headquarters for the action of the general commanding. Captain Noble arrived at this camp on the evening of the 11th with a detachment of sixteen men, leaving Fort Temon on the morning of the 10th. Captain McLaughlin had not yet arrived at the fort. When the order arrived Captain Noble, learing its purport and having been a dvised by messenger the day before to hold himself in readinesss at once left with all the men that could be spared from that post without further orders. Captain Noble has returned to Fort Tejon for the balance

of his company and will arrive in about five days. Twenty-eight of the home guards have been doing duty at this camp for the last ten days. I did not deem it necessary for them to remain any longer. They were therefore dismiss d from further duty this morning. I permitted them to retain thirty carbines with twenty rounds of ammunition each, so as to be ready for any emergency that may arise. That company consists of sixty-odd good and efficient men, well drilled, and in case arms could be promised for them they will render reliable service in preserving the peace or putting down any attempt to open insurrection. With the military preparations now being made in the rebel counties in this part of the State, I apprehend to further trouble of a serious nature, unless the State should be carried on the 2d of September for Downey and his co-rebels. In the event of their success an outbreak is inevitable.

The want of a sufficient number of enlisted men has rendered necessary the employment of a large number of citizens as laborers. The very great loss of oxen, nules and horses has driven many freighters from the road, and we may find some difficulty in laving all our supplie brought forward this season I propose sending Captain Hughes, assistant quartermaster, to Walluda to make the necessary arrangements about our supplies. I regret very much to inform you that I have heard nothing about any medicines or medical stores being en route for this post.
