#### MOXEE SCHOOL DISTRICT ELECTION SEPTEMBER 19, 1967

#### PROPOSAL I:

PROPOSED SPECIAL LEVY SEPTEMBER 19, 1967.

This is identical to the proposal submitted to the voters on May 13, 1967 which failed because of the lack of enough voters to validate the election even though it received an overwhelmingly favorable vote.

The need and reasons for asking the special levy remains the same as before:

- The money is needed to replace the assumed, but not available, money in maintaining the present level of education in the district.
- 2. This is caused by the difference between our actual assessed valuation and that assumed by the state in the allocation and distribution of funds appropriated by the State Legislature for current operation and maintainence of local school districts beginning January 1, 1967. The appropriated money is distributed by the state assuming that local property taxes are being collected on the basis of 25% of true and fair value as determined by the State Tax Commission. Property taxes in Yakima County are being collected on the basis of 15.7% of true and fair value as determined by the State Tax Commission. Therefore, the difference between the amount collected at 15.7% of true and fair value and the 25% of true and fair value assumed by the State Department is the amount assumed but not available.

#### COST TO TAXPAYER:

- a. Our 1968 estimated assessed valuation is \$7,329,899.00.
- b. The proposed Special Levy is to raise \$52,000.
- c. Therefore, it would take seven and one tenth mills to raise \$52,000.
- d. .0071 X \$100 would equal a tax of 71¢ for \$100 of assessed valuation to raise \$52,000.
- e. If based on actual value it would be .11147¢ per each \$100 of value because property in Yakima County is assessed at 15.7% of true and fair value.

THOTOGAT II: \$102,000 BOND PROPOSAL AT SEPTEMBER 19, 1967 ELECTION. This proposal is another step in the original plan resulting from extensive study and planning which led to the approval of building plans completed in the past few years. This would complete the plan of additional classrooms at the Moxee Elementary site until it reached the size of Terrace Heights which is considered maxium size for elementary schools. The next step in the plan would be an additional site for further construction to service additional elementary students in the next few years. At the present time our facilities will be taxed to accommodate our present enrollment and can definitely not handle any additional growth expected in the near future. At the present time we will have nineteen (19) classroom sections at the Terrace Heights site and sixteen (16) at Moxee Elementary site. This is being accomplished by using two sub-standard classrooms and requiring the band and music to be handled in areas that are also assigned to other activities. We have made arrangements for the transfer of some students from over-crowded sections of the Terrace Heights to the Moxee School where an additional classroom was put into service. Everything looked good until the problems of Holy Rosary School caused the transfer of a number of their students to the public school. The proposed addition is planned to relieve over-crowding, when it exists, at either the Terrace Heights or Moxee School. Most children are transported so it would be possible to make assignments according to space available at each site. MOXEE BUILDING PROPOSAL PROPOSAL: To build a four classroom addition to the addition constructed in 1965 at the Moxee Elementary site seperate and independent of the original building except for lunch services and physical education needs when necessary to be conducted inside. Identical duplication of four classroom addition approved and built at Moxee Elementary site in 1964-65. The total size of the four classroom addition is 5,476 square feet plus square feet of covered walkways. Each classroom to measure 37' X 37' less a portion of each room to be used for centrally located lavatories and housing for individual furnace units. The classrooms will comfortably handle thirty students per room for a total of one hundred and twenty students. ESTIMATED COST: The architects estimate of construction cost is \$98,435 including architects' fees and state sales tax. The additional money requested is to be used in partially equiping the classrooms. This estimate is lower than an estimate based on state matching square foot cost ceiling because of the planning in the original construction for this addition.

#### PROPOSED FINANCING:

- 1. The construction could have been financed by a special levy which would have required the collection of the money in one year by levying approximately 14 mills. This would have been levied one year only.
- 2. The Boards choice was a Bond issue to raise the \$102,000 to be paid off over a twenty year period.

a. Nothing would be paid back the first year. (1968)

- b. The second year (1969) only the interest would be paid which would require a levy of .55 of a mill on our present assessed valuation.
  - 1. Based on present assessed valuation this would cost the taxpayer five and one half cents (5½) for each 100 dollars of assessed valuation.
  - 2. Based on actual value this would cost the taxpayer eighty six hundreths of a cent (.86¢) for each 100 dollars of value.
- c. The third year (1970) and each succeeding nineteen years the interest and a payment of the principal would be paid requiring .96 of a mill on our present assessed valuation.
  - Based on <u>present</u> assessed valuation this would cost the taxpayer nine and 6 tenth cents for each \$100 of assessed valuation.
  - 2. Based on actual value this would cost the taxpayer one and one half cents (.015¢) for each \$100 of value.
- d. We must keep in mind that these estimates are based upon present assessed valuations. In our district our assessed valuation is increasing each year because of new construction and re-evaluation of property. Our evaluation has increased over two million dollars since our last bond issue in 1964. Each increase tends to reduce the number of mills necessary to raise the needed amount of money to service the bond issue.

#### WHY THE PROPOSAL?

Enrollment increases have reached the point of some over-crowding and some use of sub-standard classroom space in our elementary schools.

Projected enrollment figures indicate further over-crowding in our elementary schools in the near future.

This proposal is another step of the original plan of 1958 resulting from extensive study and planning and repeated again in 1964 which predicted the need for additional elementary classroom space in approximately three years from that time.

This years enrollment will have surpassed the projected enrollment for this date in the elementary schools.
