WASHINGTON GAS LINE CONTRACTS AWARDED

Construction contracts covering 420 miles of main line and 340 miles of laterals for the Pacific Northwest-Pipeline Corporation's natural gas transmission system in the state of Washington were awarded today. Announcement was made by R. D. Ricketts, President of Fish Northwest Constructors, Inc., designers and builders of the 1487-mile natural gas line from the San Juan Basin fields of New Mexico to the Pacific Northwest. Fish Northwest are agents for Pacific Northwest Pipeline.

These contracts cover the major portion of construction scheduled for completion in 1956. Several contractors are already in the field, with all schedules underway in the near future. Fifteen contractors will be working on schedules in Washington in the spring of this year.

Main line contracts call for 26 inch diameter pipe, with laterals of 20", 16", 12", 8", 6" and 4" pipe. Main line system awarded begins at a point near Plymouth, Washington, to Sumas, near the Canadian border. Laterals include lines to Walla Walla, Spokane, Wenatchee, and the Columbia River crossing and lateral to Portland.

Contracts were also awarded for 129 miles of laterals for Idaho markets in Coeur D'Alene, Moscow and Lewiston.

When completed the natural gas transmission facilities will cost approximately \$218 Million.
