As you have seen from clippings sent, some of the Republican organizations in Oregon are breaking the "silent barrier" by endorsing Mr. Nixon.

Dear Jack:

In my humble opinion Social Security (and Medicare) will not be settled by the 90th Congress.

I see this highly inflationary trend continuing and presenting quite a "campaign" or "pre-campaign" issue. The skyrocketing costs have been pin-pointed, but I do not believe they have been coupled with inflation or an example.

Hospital care here has risen from \$27 a day to more than \$40 a day and are still climbing, here, and the national average I believe is something like \$57. The Washington Bureau writer in the Oregonian, clipping attached, predicts \$75 a day in three to five years.

The common voter or citizen understands when he learns he could go to a first class hotel, have better meals and better accommodations, outside of special equipment of course, for half of what he pays to a hospital now. And that doesn't include the doctor's fees!

The doctors here say that Medicare is so complex that they have received NONE of their billings yet from Medicare. (I'm going to check into that story-wise). The doctors, and there are none in this region whose income is less than \$20,000 to \$30,000 a year, didn't lose the battle against Medicare. They won it, financially.

Any way you look at additional Social Security, youare looking at another increase in taxes, from the ordinary viewpoint. Like the much talked about yet never touched Income Tax structure, both have many wrongs which need correcting. A look at the increased administration cost in both would

I feel, be revealing.

Dear Jack:

As promised, that at appropo time I would send you a copy of the Yakima Eagle, a weekly newspaper, with suitable comments.

From here on out I believe it can be assumed the Eagle will be a mouthpiece for Mr. Nixon and Mr. Goldwater.

It is published by a wealthy Yakima manufacturer, Floyd Paxton, who founded the Ultma-Conservative party last November and ran for 14th district Congressman on a strong "Get Out of Vietnam" campaign.

In 1964 Mr. Paxton publicly offered shares in his manufacturing plant to his employees if Mr. Goldwater was elected. Our paper publicized Mr. Paxton's inaugural entry into politics, commenting favorably upon it editorial wise. In our news conferences I opposed a "play" for him, ribbed the executive editor etc. (who within two years was threatening to sue the Eagle for libel:)

In the 14th district congressional race, 12 counties, 180,000 voters, Paxton spent a minimum of \$80,000 (exclusive of what the paper, the Eagle, cost him). Congresswoman Catherine May, Republicans etc. were scared to death. I told them they were silly to feel that way. Congresswoman May received more than 70,000 votes, Dr. Gustav Bansmer, surgeon, slightly over 30,000, and Paxton about 9,000. And I do not believe the Ultra Conservative party, in three races in the state, obtained sufficient votes to remain on the ticket at the next general election, under their original name.

Several weeks ago I told the executive editor I was glad to see that he and Mr. Paxton had kissed and made up. He said "How come?" And

I said that before long he would see the Eagle expressing itself for Mr. Nixon etc.

The Eagle regularly carries the J. Mirch writers, book reviews, and the John Birch Radio log.

Personally were I a Candidate for <u>any</u> office, the Eagle endorsement and backing would loose me votes, in spite of a heart warming appeal against taxes and more taxes, in an attempt to gain a strong following.

A two-week campaign to enlist a"taxpayers" "Right to be Heard" movement, an open meeting, drew less than 100 persons.

It may be that because of widespread contacts, various copies will be of value to you. I will ship them along, from time to time.

Personally I believe it represents a perpetuation of a determined move evidenced at the 1963 convention.

And as I have noted before, I understood from good authority that Mr. Paxton besides spending a known \$80,000 on his campaign here last November, helped along Mr. Reagan's campaign in California by \$60,000. It was common knowledge here only.

Strange, the Eagle seems to speak for a lot of people, even you and I in some matters I suppose. But where do you draw the line? Certainly there's nothing Red or even slightly pink in either of our makeups. And as for Communists, either of us have as little use for them as the Eagle.



Rep. Brachtenbach is a "comer" in youthful Republican circles, is an officer of the 4th Congressional District Republican Club and in charge of financial campaigns for approaching elections.

Dear Robert McIntosh:

I'm enclosing some stamps for your stamp supply, and others will come, occasionally to help out a little bit; this pending a later time when there's a specific address to send any small contribution in the cash line.

I've an idea that appeals to me but probaboy isn't practical only in certain instances, because it smacks of bitterness and that is not intended. I dislike "bitter remarks" and campaigns reflective of "low blows." But every time I look at some of the National GOP publicity magazines, cartoons etc. they are loaded with personality attacks. I don't believe the general run of Americans care for that, and in the long run, it reacts against the GOP.

My personal idea, a gimmick for certain situations, is a cash donation of the amount deducted from my salary check (weekly check). My rough feeling would be if I can help out my government in this means, week after week, for at least one week I can help out my government in going in a direction in which it is going, rather than blindly, as now.

My contribution would be accompanied by my"take home" pay slip, showing tax deductions. And there's an old expression, "Put your money where you know it will do some good."

Thanks to an early start on names of persons inclined toward the Governor, I think this particular area has nearly enough lined out to forestall any "raids" by blanket committments from political leaders. They can't truthfully say now "we are all for" so and so, and many of the names

are political committee members or high in the party.

The Young GOP waited until March for its Lincoln Day banquet and has not yet named a speaker. I think the reason for waiting is obvious but I may be wrong.

I am not concerned that the GOP will not make at least a 60 to 65 per cent showing next November, in this region. I am concerned only that some of the old party workers for Mr. Nixon, still party leaders as they should be for the work they have put in are still determined that he can win, overlooking that many voters like him but feel he hasn't quite got it.

I am glad the word got around here last December and that sentiment or rather confidence in the Government was predominate then. It has grown remarkably since, on its own legs.

I hope you get a "chain letter" response to your letter to residents of this area with more names to add to the Governor's support list. Your mail is coming through. I received a few calls today. I encouraged them to submit any other names of persons they know who wish to see the Governor nominated if he choses to run.

Don't worry about writing me only when there is something specific you wish. When it comes to something like this, I do like I used to run the half mile: Aun the first quarter as fast as you can and then follow up by running the second quarter as fast as you can. You usually place up toward the front. Lots of people are good for the first quarter but slow down.
