I was not so much seeking information, because you have already made available for me information which with that already at hand, is more than I can use in the proposed volume on Northwest History as it related to J. H. Wilbur.

Dear Friend Click: Last December I had a copy of this chapter ready to submit to your scrutiny. I loaned it, with other chapters, to Bishop Everett W. Palmer. He in turn sent it to Dr. R. Franklin Thompson of University of Puget Sound, Tacoma, and to this day I have not seen it again. This was ready some weeks ago, but I have been busy on the appendices of the book and did not get it off to you. I am enclosing a copy of the explanatory notes applying to this chapter, so you can see what credits I have given. I have made use of some of your material and have given you credit. I hope this is satisfactory to you. While I dislike to punish you by requesting you to read the chapter. I am anxious to have your suggestions in case I have erred anywhere. We hope to get the typesetting under way soon after August first, but have been delayed in the project because of slowness of the Methodist Churches in the state to meet their quotas of sales. My Dear Friend, Click:

Thanks for your letter and the check that came a few minutes ago. I am forwarding the check to Chapin Foster, at Wesley Gardens. He has a person there who keeps the books.

Chapin and I met with the Bishop and his cabinet Thursday and we decided to send the manuscript in and get work started on it. We ought to know soon how long it will take to complete the publication.

Thanks for the thorough job you did on the chapter on the work among the Indians. You did more work on it than I dared hope you could spare time for, but I appreciate greatly the work you did.

Concerning the statement that Wilbur had usurped the authority of the resident agent, I found that in the published reports of the Department of Indian Affairs for that time. I took that statement to mean that the writer thought Wilbur was making decisions which should have been made by the agent. Dr. R. H. Landsdale, then agent, was a Methodist and probably shared Wilbur's feelings in the matter. Wilbur was an overshadowing personality and probably did dominate the agent.

Our report to the cabinet and the Bishop Thursday showed almost 2700 sales and guarantees by churches. The Cabinet felt we should have 4,000 published on the theory that many persons will purchase volumes they can see who would not buy on the strength of a promise. The extra thousand will cost much less per book than the first three thousand. So we may proceed. We had hoped to get the book out by Christmas, but feel that it is too late for that now.

Again thanks for all your help. Hope the book will prove worthy of all the time you gave to it in my behalf.

Chapin did not last to see the book in print, but he put in many hard days of promotion and advise to me.

The last of the pre-publication orders was filled June 1, and on June 6 I came down with what the doctors diagnosed as pericarditiss which kept me in the hospital from June 11, to July 10, and at home without communication with friends for another four weeks. Since that time I have been taking things easy at home. Feeling pretty well now, but still have a good piece to go.

Please note that we did not move to Wesley Gardens, Des Moines, but still reside in our home in Seattle.
