Local Special Fishing Regulations 1943 Season

With the exceptions noted below, the State of California Fishing Laws are identical with those of Sequoia National Park:

The following Special Regulations, issued under the authority of the Rules and Regulations approved by the Secretary of the Interior (June 18, 1936 - 1 F. R. 672) are in force and effect within the boundaries of Sequoia National Park:

THE FOLLOWING WATERS ARE CLOSED TO FIRMING TO ACT AS FEEDER STREAMS FOR RESTORING MAIN WATERS:

CLOSED WATERS:

- On the watershed of the North Fork of the Kaweah River
 Cabin Creek from source to junction with Dorst Creek.
- On the watershed of the Marble Fork of the Kaweah River

 Deer Creek from the foot bridge on the Sunset-Village Trail to source.

 Silliman Creek from source at Silliman Lake to Bridge on the Generals Highway.

 Wolverton Creek from above the Wolverton Dam where signs are posted.
- On the watershed of the Middle Fork of the Kaweah River

 Crescent Meadow Creek, source to High Sierra Trail Bridge at lower Crescent Meadow.

Note: On that section of the Middle Fork of the Kaweah River between the Hospital Rock Trail Bridge and the Edison Company No. 3 Powerhouse Dam, fishing, picnicking or visiting are permitted only between the hours of 5700 and 8 P.M. NO FIRES for any purpose are permitted in this section without written permission from the Superintendent.

On the Kern River the section of the Kern River between the Chagoopa Bridge and Rock Creek.

THE FOLLOWING PARTS OF ALL STREAMS AND LAKES WITHIN THE PARK ALSO ARE CLOSED TO FISHING:

All lakes within 300 feet of the inlet or outlet.

All streams connected with any lake shall be closed for a distance of 300 feet from either the inlet or outlet of the lake.

When any stream connecting two lakes is one-fourth mile or less in length, the entire stream shall be closed to fishing.

OPEN SEASON May 1 to October 31, inclusive.

LIMIT OF CATCH:

THE LLLIT OF CATCH SHALL BE (15) FISH PER DAY CAUGHT OR IN POSSESSION, OR (7) POUNDS AND ONE FISH IN ALL WATERS OF THE PARK.

POSSESSION OF MORE THAN ONE DAY'S LIMIT BY ANY ONE PERSON AT ANY TIME SHALL BE CONSTRUED AS A VIOLATION OF THIS REGULATION.

FISHING LICENSE:

A California State Fishing License is required of all persons over 18 years of age fishing in the park.
