RESPONSE TO OUR PARTY AND TICKET PROPOSAL UNBELIEVABLY OVERWHELMING

HERE. WE FIND SENTIMENT SAME ALL OVER COUNTRY AFTER ACCURATE SAMPLE

POLLS.

THERE IS STILL TIME TO FILE PARTY IN 32 MORE STATES, HAVING TOTAL OF ABOUT 350 ELECTORAL VOTES, INCLUDING ILLINOIS, MECARTHUR-BYRD TICKET CAN WIN NECESSARY 266 of 350 FOR VICTORY. YOU PROBABLY DON'T REALIZE THAT THERE NOW EXISTS MOST EXTRAORDINARY POLITICAL SITUATION IN OVER ONE HUNDRED YEARS OF AMERICAN POLITICS.

REMEMBER, STEVENSON AND EISENHOWER BOTH DRAW THEIR SUPPORT FROM SAME INTERNATIONALIST THINKING SOURCE. TRUE MEANING OF THOSE MOST AMERICAN OF WORDS, AMERICA FIRST,

CANNOT BE DEFILED OR TARNISHED FOR LONG, IN SPITE OF VENOMOUS SCHEMES

AND ACTIVITIES OF UNLAMERICAN ELEMENTS OF BOTH RIGHT AND LEFT
