I'm sorry you had to rush in and out of Yakima the other day, and that I did not have an opportunity totalk to you.

n relation to remarksmade at the public meeting of the Board on April 14, I am writing to request that inasmuch as my name was brought out in connection with a letter written by Mrs. J. J. Bartholet of akima, I be sent the excerpt from the letter, pertinent thereto.

I have always endeavored to avoid any conflict, realizing that there seems to have been a feud simmering between various individuals. But I have picked up in Yakima that it has.

As the possessor of that letter (not the original) and sticking to the truth and accuracy of history, I do not wish to be used in this situation and refuse to let others bring me into it.

have been compelled to listen, for long periods on end to Mrs. Swanstrom, which I did gladly, expressing no views but an appreciation of the work she has done.

I have also madargame the same sympathetic ear to Mrs. Bartholet. But if the situation has turned to that of pitting individuals against individuals, I draw the line. I wish and will insist on remaining friends to all and upholders of no issue but what is proven on the

record.

People seem to be making mountains out of molehills. Nothing will ruin or disrupt an organization, its benefits or the product of its benefits sooner.

I see the time is approx him that the legislators should be acquainted with the value of such things as Fort Simcoe and through the news columns of our paper, this is being done. That is one of the greatest values of the research, at present, that and build a record to assist in the project.

I would suggest that any abstract material required by the ommission be prepared by H. Dean Guie. It would be a difficult task to compile a two-way report. Hope things are going well with your other work. From now on I suspect will be an ever busier season than before. But you seem to be the kind of a fellow who can take it.

I'll try and round up an extra copy of Mrs. Kimmel's Fort Simcoe Story, another pamphlet publication, 26 pp. That makes two for the record the research committee members have produced, but they won't learn to submit their material for cross checking of accuracy. Inasmuch as it is their personal projects, there's nothing you can do about it. I believe I provided you with a copy of Mrs. Travis' Mool Mool.
