Frankly, Mr. Relander, I share your lost faith in book dealers—or at least the majority of them. As a general rule, they are just about the poorest bunch of businessmen I have ever had an opportunity to work with. It would seem that a book like your DRUMMERS AND DREAMERS could very well be and certainly should be a best seller throughout the Northwest if it were properly displayed and if the point could be gotten across to these dealers that no one is going to purchase this book or any book unless they know it is for sale and see it displayed. I realize, of course, that this kind of attention cannot be given to each of the hundreds of titles which a dealer may have on his shelf, but there are certain perennial best sellers or potential best sellers which deserve this kind of attention, and in my opinion, your book is among these.

We have given a great deal of thought to reprinting DRUMMERS AND DREAMERS, but as much as we would like to do so, we haven't been able to find the sufficient justification to bring out a reprint of your work.

Mr. Gipson and I are continuing to try to find some way to keep your book in print, as it is one we don't want to see pass off of our list. I certainly hope we can find a solution to this problem, and we will keep you informed of any and all developments.

This is dictated in reply to your letter of September 29th and is to tell you that we have had an estimate made in accordance with your specifications, on a reprint of DRUMMERS AND DREAMERS with the addition of 20,000 and additional photographs.

We have the offset negatives for the illustrations.

We figure this would make a book of 415 pages, and we could quote you as follows--500 copies, \$4150; 1000 copies \$4900; 2000 copies \$6400.

Quotations are f.o.b. Caldwell.

I just don't know what is to be done with this, Click. Production costs are so fantastic now, that even if you were able to finance an edition of 2000 copies, the book would have to sell at \$9.00 a copy.

You see, we have the expense of doing business, we have to give jobbers 50% or more discount, and to pay commissions to salesmen.

You can get an idea of what the retail price would have to be by multiplying by 3 the actual cost per copy in the various quantities.

The amount specified would not have to be paid in cash. We would want one-third when the contract is signed, one-third when the page proofs are submitted and the balance of one-third when we complete and are ready to ship the first 10 copies.

We'll be glad to hear from you and hope you can come up with some plan under which this fine book can be made availabe to those who are interested.
