I give you this information that you may save yourself trouble in the future.

Sir: I am in receipt of your reply to my note of yesterday asking the reason of your presence on this Reservation in which you allege that you are acting under orders from Gen. McDowell, U.S.A. commanding, Div of Pacific directing you to ascertain the feelings of the Piutes located here relative to a return to Malheur Reservation and to escort such as wish to return to the Columbia River accordence to. In reply I have to say that I have no instructions from the Hon Commissioner of Affairs contemplating such return, but on the contrary my latest orders from the Hon Secretary of the Interior are to hold them here. Under these circumstances it is my duty to caution you in any con unication you may have with them to hold out no pg 93

inducements not certain to be fulfilled. As any communication which holds out a possible prospect of their early return will have a tendency to unsettle their minds should the department finally conclude to hold them here. You are requested to hold out no positive prospect to them till the wishes of the Department are definitely known.

My only object in this is to take no steps not fully sanctioned by the Indian Department and not to place obstruction in the way of the execution of your orders.

Sir:

Some days since I received notice that a band of horses in chagge of a white man were being herded on this reservation without authority. I immediately dispatched my Indian police to seize the horses and arrest the white man. Last evening he was brought before me. He stated that name his 2000 was Wm. McAuliff, that him herd he had been watching was twenty-four (24) pack horses belonging to the N.P.R.R. and were now under your immediate charge; that said horses were wintered on this reservation, and from Feb. 7th to April 5 were fed from hay purchased by the N.P.R.R. from one Kingsbury p 380

that since April 5 said horses had been pastured on the reservation.

In appearing from the examination of McAluiff that he was acting under orders from superior authority without any evil intent (he stated that he was employed by the NPRR Co) and that he supposed he was lawfully on the Reservation, I have released him. The horses have been placed in charge of my police, and will be held a reasonable time for the payment of a just grazing tax and expense. If no settlement is made, I shall, after I deem a reasonable time has elapsed, cause said horses to be disposed of for the benefit of the Indians of this Reservation; unless it shall be satisfactorily shown that said animals were on the Reservation by competent authority.
