Dear Willard:

Pursuant to our telephone conversation, I am enclosing a certified copy pertaining to the death of Harry Wyena, until the date of his death, 4/11/67, an employe of the Grant County PUD. Dr. Andrew Braff, Yakima County coroner who investigated told me he noted "wound apparently self inflicted" but cases like these could be open to discussion. He said there was no suicide note and nothing in his investigation conclusive that it was suicide.

Also, pursuant to our conversation, the check covering insurance, made out to the surviving wife, Mrs. Nancy Wyena is to be delivered in Yakima so she can convert it and pay obligations she has incurred in connection with the funeral.

As an alternative, if it would better suit the PUD schedule, I could come to the office in Ephrata during banking hours and this could be attended to at Ephrata. I will have receipts which I have "vouched" for. If I come to Ephrata I would need a day's notice, perhaps two, since we are working rather short handed at this time due to illness. Additionally, I have an appointment in Tacoma to keep Friday, May 5. Whatever you decide upon I believe one person from the PUD, hrs. Wyena, of course and some of her relatives and myself should be present, and the check produced at the bank. I say this because little sums incurred in Wanapum expenses I normally absorb and they are somewhat accustomed to this. Sometimes they do not realize what a larger sum entails, especially under emotional strain. They are out now, purchasing, and until completed, they or I do not know the total.

Thank you and my PUD friends for their help, and le t me know in any Sincerely Click Relander
