Enclosed is check for \$20, balance due on shipment satisfactorily received, Order No. 9385. I appreciate, for a change, having material of this nature bound and labeled.

Relative to the Wright Topographical Memoir, I realize the "map" referred to was not with this item, but I am wondering if you know where a photostat can be obtained.

This is 35th Cong. 2d Sess. Senate. Ex. Document 32 (Feb. 1859) The "memoir" consists ordinarily (and it is comparatively "rare" as you know, small maps of Four Lakes and Spokane Plains battlefields.

However there is also referred to "and General Map in two sections of our line of March."

This would be an asset to the memoir and especially of interest regionally. If you know of one existing, I would pay \$10 for the two sections (photostat).

If the Prosch, Old Tacoma hasn't moved or still hangs around after a time, you might send it, although Prosch shows up here frequently or is shelved at \$15 to \$25, depending on condition. Sorry the Allen (Lt.) Northwest Schoolcraft escort was taken, seems like it would have been in my field.

And if 217, Hathaway, 264, Morgan and 213, Haines, are still about in a short time, you may send any or all of them. (I am going to be out of town for about two weeks).

If you have a contact where Strong, Egbert, Schench and Julian Steward's Archaeology of the Dalles Deschutes Region (California Press, 1930) also publication in American Archaeology and Ethnology V 29 No 1 is obtainable, I would especially appreciate this if in \$15 class.

I appreciate very much your courtesy in sending the items.
