Sir:

In making my annual report I have the honor to state that I have been employed at this agency as carpenter since Feb. 1st, 1870. Since that time I have attended to all the wants of the Indians in my branch of duty, making tables and other articles of furniture for them, giving instructions in house building and repairing such articles as come in need of the same.

The picket fence at the agency, destroyed by fire last year has been renovated as well as the houses occupied by employes, to some extent.

Considerable repairs areneeded yet on the latter to make them habitable for the winter.

When it became necessary to attend to other work such as acting as superintendent of farming during the persons absence and particularly of late when considerable help was needed to gether in the harvest, I have done so.

During the time I have been employed the money value of work done by me far per month has averaged from one hundred to one hundred and fifty dollars as per my monthly labor report.

Sir:

I have the honor of informing you that I arrived here on the morning of the 6th, r. S. Nelson, F.C. Prasp and our wives. We had been detained two weeks in consequence of the Columbia River being frozen. When I arrived I found the Supt. of teaching in charge of the reservation. I immediately entered upon my duties as agent and have been and am nowengaged in getting things in order to be formally turned over which will be done as soon as the papers can be made up and the property seen. In looking at this state of funds and the accounting statistics of this station I deemed it duty to request five of the employes to resign which was done within a few days after I arrived. The names of those that have resigned are as follows:

Dr. J.O. Clarke, W.S. Hays, E.R. Welch, B.F. Dozier, Islah Hamilton and Henry D. Merwin. These persons have resigned and all except one have left the service. In view of this state of the funds I think it best for the time being at least to do what is done mostly with Indian labor. Then as no school is in operation I think in the course of afew days I will gather up some of the school boys and put them into the harness shop and finish up harness that have been cut out. I see the necessity of using funds to the best advantage in order that we may give a fair account of work done with funds expended. Finding there is not funds on hand to pay the liabilities of the 4th quarter and not having a dollar on hand to do business with, you will readily see my need of funds, and I doubt not meet my wants according to the best of your ability.

Funds deposited to my credit with Messrs Ladd and Tilton, Bankers,

Portland, Oregon, will be easy of access.

Sir:

Enclosed please find an estimate of the money needed to carry on the services on this agency for the present year in accordance with the Treaty. When I arrived here I did not find the Indian school in operation. The man who stands as Supt. of instruction has been and needs still to be engaged in making up his papers of this office. To do this office writing and other work that a clerk wanted should assist in, is quite enough for one man. For the Supt. of instruction to do this office work prevents his doing for the children of this school, what what must be done to make that department prosper. The teacher should faithfully instruct six hours per day and to fore and after school. The supt. should take charge of the children making themr work turn to good account in preparing wood, work in shops and on the school farms and gardens. To have a proper man for this office would make the school department a success. I am unwilling to organize a school here on a plan simply to use school funds. Fallen humanity may be assisted in standing erect [among the Indians, Crossed out] but it must be done by taking the Indian children from the camps and instructing them in those things pertaining to industry God and heaven . "e should have for this agency a clerk. One thousand dollars per annum would mammximm secure the services needed in the office. I ask your recommendation to the department to secure such service.

The Indians are all most universally destitute of seed to put into the ground the coming spring. Very little fall grain has been sown.

They should have seed furnished to some extent or one year from now they will be destitute as I find them this winter. Please do what

you can to give us beneficial funds for mand said purposes.

I have to request you to secure the appointment of F.C. Prasp as blacksmith in the place of B.F.Dozier who has resigned.— services of Prasp to commence on the 9th day of Jan. 1871 at a salary of one thousand dollars per annum.

Also Dr. S. Nelson in place of Dr. Clarke who has resigned. Please let Dr. Nelson's services begin Ja. 11th 1871 at a salary of twelve hundred dollars per annum.

Other places that are now vacant here I propose to leave for the time being until I can know the outcome of funds and the way is better for bringing in families. I am not fully instructed in regard to the "Head Chiefz of this nation. Joe Stwire was properly elected by the people and recognized here and at Washington as the Head Chief and was paid as such until some time after Lieut. Smith took charge. Without any just reason he was turned aside, and the money appropriated to pay "Head Chief" has been used for other purposes. I have to request that he may be recognized as Head hief and paid his back salary.

You will see from thin the report I made ten days ago I have reduced the expenses of the reservation near one half since I came in. I expect to make some more changes when the proper time comes. I mean to be prudent and bring to my aid the experience of past years in dismissing and recommending men for this service.

Hoping I may has so manage the affairs of the reservation as to secure your continued approbation and the approval of the wise and good of the nation, I remain, your obedient servant

W.T. a license dated first of April, one thousand eight hundred and seventy one, to trade for one year with the Yakama nation of Indians at the following described place within the boundaries of the country described place within the boundaries of the countr

Now if the said Edgar French (sic) sax so licensed shall faithfully conform to and observe all the laws and regulations made, or which shall be made for the government trade and intercourse with the indiana tribes and in no respect violate the same, and shall trade at the aforesaid place and no other, and shall in all respects act conformally with the license granted to him, then this obligation to be void, else to remain in full force and virtue. Dear Sir

Your letter of June 30th containing a copy of one from Supt. Meachum of the Oregon superintendence complaining of the "presence of Indians" in Yamhill county belonging to this agency is received.

Supt. Meachum states that the Indians were "gathered up five years ago by Supt. Huntington and Sent up to this Agency, and that less than two months after they were back again by permission of Agent "ilbur."

That Supt. Huntington gathered up Indians and started them to this Agency and that a few of them came here is true, but that Agent Wilbur permitted them to return in two months is not true. Most of the Indians now complained of were here upon this reservation when I turned it over to Supt. J.M. Smith and when I returned to the duties of this agency the Indians of which Supt. Meachum speaks and a great number more who belong tothis reserve, were scattered to the four winds.

I am ready to gather up all the Indians belonging here when you so direct and instruct me in regard to meeting the expense, ket that must arise in said work. I have always extended myself to the utmost to gather and keep the Indians belonging here in conformity with the treaty made.

Duringthe month the grist mill has been repaired & I have worked several days on that all of which is respectfully submitted.

I have with the farm laborers in Department Service, made two trips to the Dalles, one with a four horse team and one with a two horse team.

Got up Department cattle marked and branded all young stock that was not branded. Drove all the cattle to winter range. Halled timber and bridged the Topnish.

Repaired the road leading to the Dall for a distance of eleven miles.

Done the butchering and taking care of stock and teams about the Agency.

Sir:

I have the honor to suggest in relation to annuity goods that the season is so far spent that with any considerable delay in having the goods at Dalles City, Oregon, it will be difficult, if not impossible, to get them in. The snow is beginning to fall on the mountains and the wagon road will not be passable longer than the 15th of November.

Our school has opened with thirty two children and we could gather in many more if we had means to cloth them. I think one thousand dollars of the money might be laid out in the purchase of cloth for the clothing the girls and boys of the schools and turn to better account for the nation than any other expenditure I can suggest. Should you deem it best, these things could be purchased near here by the Agent to meet the wants of the children perhaps better than elsewhere. This however I leave to your wisdom.

I think material to make twenty setts of team harness, including buckles, rings, haimes, collars & siather (?) also bridle leather for 4 doz bridles & the trimmings etc and the remainder to be laid out in good blankets.

whatever you may deem best in the and attacked selection of articles above suggested, or others your wisdom may deem better, will be strictly be acquieced in and put to the best use by your humble servant.

Sir:

I have the honor to communicate to you the fact that certain parties around the border of the reservation are committing trespass upon the agency, by cutting & hauling timber from the agency to fence their land and furnish themselves with fuel. I have protested against it, and find that a class of them, seem above all law in the matter, and I ask particular instruction in reference to it.

"Iso, some parties are turning in stock without permission, and without giving any compensation. Evidence in relation to the former and latter could be had that would not leave a doubt. Shall I prosecute said parties? And if so, can I secure council and pay for such council? Out of what fund must I pay? Unless there are measures taken to check the lawlessness we suffer great damage and shall ere long have difficulty between the whites and Indians. I trust I may be favored with an early asswer.

ir: I have the honor to acknowledge your letter charging Spencer with stealing George's wife and taking her to Montecello and causing George Thouble, and expense. I have had Spencer at the office and he gives a different version. He says an Indian by the name of Elo-nal-lac living in the Cowlitz went to Nisqualla and took said woman to Montecello, that "eorge followed himfrom Nisqualla to Monticillo found the woman and Elo-kal-lac and Elo-kal-lac gave corse a horse to settle the difficulty. That George gambled month the Indians at Monticello and won and took away four of their horses that he pencer had nothing to do with said woman and is accused wrongfully. Spencer wants you should see that George returns the 4 horses he won by gambling at that time. He got the horses as I understand from an Indian by the name of Paddy. I think it right to require him to return said horses. Spencer says if George persists in lying about this matter as he has to you he will come to Olympia at your office and meet George and wife with the Indians who know the whole history. So I shall not force any payment of eorges expenses until H have better evidence of spencer's guilt. Please make inquiry and report and between us we will make the matter right.
