Newslett OPERATION EQUAL Housing Commisses of Activity Progress Reported olume 1, No. 2 Newstetter September From The Front Desk The past two months have been marked by visible short term success coupled with possible long range set-backs for the overall Operation Equality program.

In the King County and Southern Snohomish County areas, good progress has been made in strengthening and establishing fair housing listing groups. The effectiveness of our fair housing volunteers is reflected in more than 100 listings received during the month of August and the placing of six families in housing units during the first eleven days of September. COUNTY PROGRAM ROADBLOCKED: DOTAL BOTH AL BUTYLL WOR STUBOLINGA On the debit side of the ledger are two blows to our blueprint for an increase in the overall supply of low-and moderate-income housing. In early September, it was discovered that the King County Commissioners had not filed the necessary papers required to requalify the Federal Workable Plan. This means that after Settember 30th, and until such time as the Commissioners choose to resubmit, no federally assisted housing for the poor, for low or moderate families can be built in the unincorporated areas of King County. Not only is the King County Housing Authority crippled, but nonporfit sponsors such as churches and unions, and limited dividend sponsors comprised of builders. sors comprised of builders and realtors will be unable to qualify for these federal housing programs. appropriate volunteers soon. A second major blow came from Washington, D.C. where the Rent
Supplement Bill has emerged from Senator Magnuson's Senate Appropriations subcommittee in such a state of emasculation as to render
it almost useless as a tool for the construction of housing for lowit almost useless as a tool for the construction of housing for lowincome Americans. The Senate committee, while restoring funds cut by the House of Representatives, concurred in an amendment which would require non-profit sponsors to contribute 5 percent of the total costs of construction and land. Under the present bill, such sponsors receive
100 percent federal financing.

Since nonprofit sponsors cannot earn any funds from rent suppleemnt construction, this amendment effectively eliminated from participation the very groups who have built most of the low income housing constructed under the existing act. In short, low-income housing cannot now be built in King County unincorporated areas, and the Rent Supplement Act appears lost as a viable tool for such housing on a national scale. Unless the King County Commissioners can be persuaded to take immediate steps to recertify the Federal Workable Plan, and unless Congress can be persuaded to remove the 5 percent provision for non-profit sponsors from the Rent Supplement Bill, we will lose nationally valuable housing tool and a sizeable local area will be closed to all types of federally assisted low and middle income housing.

In this and future Newsletters, some of the more frequently asked and/or most probing questions will be answered on the assumption that these are also the kinds of questions you meet when you tell people about our program. We hope you find this useful.


Question: Where do you draw the line as to where the Central

Area is; the ghetto?

Answer: The modern rule of identification for any ghetto or ethnic enclave is the predominance of persons of a common bond (usually racial) in a geographically definable area who live there because property is more easily available to them in that area, as determined by the Real Estate Industry, by the Mortgage Banking Industry, by the codes and regulations of federal housing agencies, by local zoning practices and by majority population consent. The office of Population Research (1960 data) shows that Negroes are concentrated in a converged area, the heart of which is between East Mercer and Yesler Way, 15th East and 31st Avenue. The total area is bound by Lake Washington Blvd. on the East (census tracts J1 and Q1); 15th East on the West (census tract K1); East Mercer on the North (census tract K2) and South Irving on the South (census tract Q1).

It may be pointed out that while Seattle does have a black ghetto, it does not yet have a comparative slum. What it does have is a restricted, frustrated, disenfranchised black population who in many instances remain isolated not from choice but because they

have to.



League of Women Voter's New Home

As of Friday, September 8, 1967, the League of Women Voters is at home at 1402-18th Avenue in its newly-acquired Central Area quarters.

Joan Thomas, State President and Edith Lobe, Seattle President, began to feel isolated from the happenin's which were occuring (or threatening to occur) mostly in the Central Area. Kay Bullit asked

Operation Equality to help the League find quarters in the area.

By putting Margaret Clise and other L.W.V. principals in touch with Gil Baker, who just happened to have recently acquired and re-habilitated a vacant old eyesore, we did help. Congratulations all around: to Gil Baker for foresight and

community pride; to L.W.V. for courage and concern. Welcome!

Discrimination Western - Style: An O. E. "Failure?"

Early in the life of Operation Equality, a young, governmentemployed Negro woman of middle-class circumstances filed an application for a one-bedroom unfurnished apartment on Capitol Hill.

Our Field Representative, Ira Oakes, made an intensive search and finally came up with what he calls "a winner." The applicant was referred to the building manager who showed her the accommodation and accepted the necessary funds. We thought that we had scored a "success." We told our National Office we had.

When the young woman arrived to take occupancy, the manager 'regretfully' returned her money. Why? A present tenant had suddenly decided to take the apartment and there were no other vacancies which

fitted the applicant's needs.

The search for a one-bedroom unfurnished apartment on Capitol Hill began anew. An apartment house manager, who had been cooperative in the past, was approached. Her response was almost tearful and, we believe, genuinely regretful. Four Negroes were living in that 48 unit apartment and she "just couldn't take anymore." Her quota had been filled.

The search goes on ... and on ...

Weeks passed. Managers said that units advertised for rent had "just been rented," when approached by the applicant. They simply hadn't had time to remove the vacancy sign out front. They did so just as soon as the young woman left. A subsequent check back by telephone or by white checker found several such units "still available."

The Human Rights Commission was called. John Eichelberger interceded with persuasion and logic but to no avail.

The search went on. KING-TV and radio publicized the plight of this "qualified Negro" applicant. A studio apartment and a twobedroom unit were called in by owners, one of which was available only to the publicized applicant. Unfortunately neither accomodation fitted the applicant's needs.

The Mayor's office was asked to assist. The Apartment Operations of the contract of the co

tors Association was also directly approached. To no avail.

Today, nearly eight weeks later, there is no one-bedroom, unfurnished apartment available on Capitol Hill--to a Negro, that is. Who's got the answer?
