On my next trip to Yakima I will present an autographed copy of "SIX ROADS FROM ABILENE" to Eisenhower High School. Edgar will sign the book special.

Next Wednesday I go to Washington State University to give the college Library the original manuscripts of both the Eisenhower and Hollywood books. On my way back I will try to stop off and visit with you.

Thank you so very much for the clippings and the nice letter. Both Torchy Torrance and I appreciate the news story about the books very much.

I will bring the autographed copy of the Eisenhower book with me when I come to Yakima to address the Feed convention.

I was in Spokane and down on the Washington State University campus last week (five days), and had planned to stop off at Yakima on my way back to see you and Vic, but all that heavy snow forced me to come back via train and it was in the middle of the night when We passed through your town. So I came straight to Seattle.

I met several of your fans at WSU, people in the history department and over at the library. They enjoy your writings very much. One of the officials over in the archives section of Holland Library said, "Click is a real pro. No one knows the history of the Northwest Indians better-- and what's more, he knows how to write about them so that they seem to come to life again."

Plans had been arranged for me to leave next Monday on an eight-day nine-state book promotion personal appearance tour on Western Airlines, but I contracted the flu and don't feel too hot; so I have instructed Torchy to cancell out the trip until later. My plans are to come to Yakima for the Feed convention, then go right on to New York for several weeks to promote the books back there. I can take the Western trip upon my return.

King Features gave "Six Roads From Abilene" a tremendous review last weekend. It appeared in more than 200 papers. See enclosure, a reprint of it as it appeared in the New York Journal-American. The NY Journal-American even phoned from New York wanting to serialize the book in eight parts, but we decided it would hurt book sales at this time; no reason for giving the book away to readers.

Keep punching and I will see you soon.
