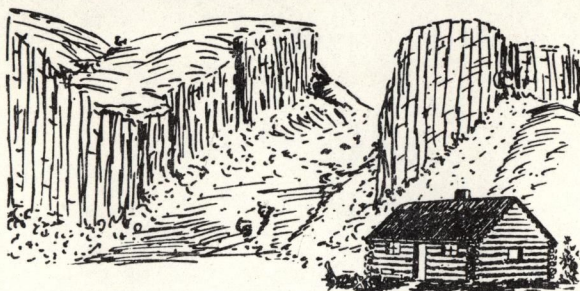

The requirements of the Society are only that members have a genuine interest in the work and pay the annual dues.

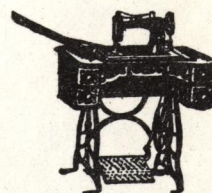
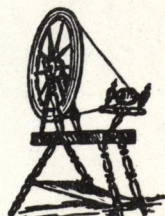
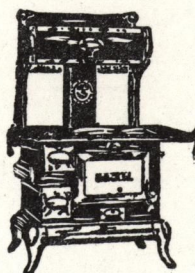


WHAT THE SOCIETY OFFERS ITS MEMBERS

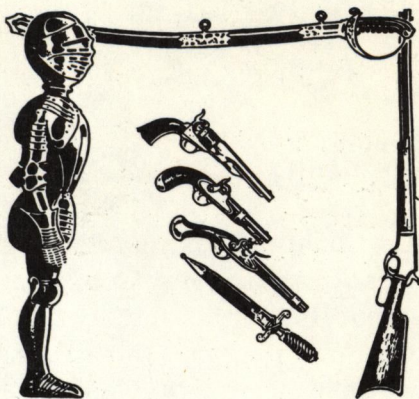
NON-PROFIT ORGANIZATION

The Grant County Historical Society is an educational, non-profit organization incorporated within the laws of the State of Washington. Donations to the Society are income tax deductible.

As a member of the Historical Society the fees are used for the building fund, correspondence, cataloging, and other operation costs. Officers serve without pay. Members may support by donations, several of the other projects as the building site development, photographing or taping fund. Money donated is placed in the general fund unless otherwise directed.
