1. Seller agrees to place fire, theft and such other insurance as the seller deems advisable thereon at purchaser's expense, during the term of this contract but not after the date specified for the payment of the last installment of the purchase price and without deduction for prepayment of such purchase price, loss payable to seller and purchaser as their interests may appear for the total cost, including both seller's service charge and insurance premium, shown on the face hereof.

2. Title to the property shall remain in the seller until the full purchase price has been paid. The purchaser shall take immediate possession of the property and shall keep the same at the address indicated on the face of this form to which seller is making delivery, during the term of this contract unless written permission to remove said property shall first have been obtained from the seller.

3. The risk of loss or damage from any cause shall be upon the purchaser. The destruction, loss or damage of the property shall not relieve the purchaser of his obligation to pay the purchase price in full. The purchaser shall keep the property in good condition and re-

pair, and shall pay all taxes thereon.

4. Time is of the essence of this contract. In the event the purchaser shall fail to perform any of his obligations herein contained, or should the purchaser return the property without the consent of the seller, then in either of said events the seller may elect either (1) to declare the entire unpaid balance of the contract price immediately due and payable without notice or demand to the purchaser and enforce the performance by the purchaser of his obligations herein contained, including the payment of the unpaid balance of the contract price, or (2) to retake possession of the property herein agreed to be sold with or without legal process. The purchaser waives all claims for damages due to or arising from or connected with any such retaking. In the event the seller shall elect to retake the property, this contract shall be terminated and all payments made by the purchaser shall belong to the seller as compensation for the purchaser's use of the property and its depreciation, and not as a penalty. In case of such repossession, the seller may apply the value of the repossessed property, or may sell said property at public or private sale and apply the net proceeds of such sale, on account of any unpaid balance of the contract price hereunder, and the purchaser shall not be discharged from liability for any portion of the contract price remaining unpaid after such application, and agrees to pay such portion to the seller. If any action shall be brought by the seller to enforce any right of the seller hereunder, the purchaser shall, in the event judgment shall be obtained by the seller, pay the seller a reasonable attorney's fee which shall be included in the judgment.

5. In addition to such other rights as the seller may have hereunder, in the event the installment purchase price or any installment thereof is not paid by the purchaser at the time and in the manner herein provided the purchaser agrees that the purchase price shall be increased, at the option of the seller, either (a) by five per cent of the amount of each installment which shall not be paid at the time provided, which additional sum shall be paid upon demand by seller at any time after each such default shall have occurred: or (b) by onehalf of one per cent of the original unpaid balance for each month or portion thereof during which any default shall continue, which addi-

tional sum shall be paid upon the last installment payment date or upon demand by seller.

6. No act or deed of the seller, other than an agreement in writing executed by a duly authorized officer thereof shall be deemed to have waived the provisions of this contract that time is of the essence thereof, or to have waived the right of the seller to enforce a forfeiture of this contract for breach of any term or covenant thereof by the purchaser. The waiver by the seller of one breach of this contract by the purchaser shall not be deemed a waiver of any subsequent breach.

7. The interest of the purchaser in and to this contract, and/or the property therein referred to, is not assignable or transferable other

than with the written consent of the seller.

8. This contract contains the entire agreement of the parties and there are no representations, warranties or guaranties, either express or implied with reference to the sale herein agreed to be made or the merchandise herein described, other than those express representations, warranties and/or guaranties herein set forth.
