The P-I's recent review of your new book, STRANGERS ON THE LAND, reminds me to send you an announcement of the Seattle Indian Center's FIRST AMERICAN INDIAN HAMDRAFT EXHIBITION with the hope that you may be in Seattle during the show (March 30-April 6), or possibly be able to attend the invitational preview this Friday, 7 to 10 p.m.

This looks like a good chance for the Indian people themselves to start touting the commercial wholesalers of Made-in-Japan totem poles, etc., which the visitor finds for sale at the Space Needle and on Hurricane Ridge. The initiative for this exhibit came from Mrs. Pearl Warren, director of the Indian Center and a member of the Makah tribe. Coordinator is a Quinault, Francis Edward Mason. Help on the installation is by a UW graduate student in art, Donald Scott, a non-Indian, but otherwise the show is the Center's project and I hope will become an annual event when this UGN agency moves to its new location next month, a former church building at Boren and Stewart.

It is too bad that such a long-time friend of the Center as Harry Burks, of the American Friends Service Committee, did not live to see this offering of the Indian people's very best craft work for exhibit and sale. He would have approved both the pride and self-assirance it shows.

Naxine Curhing Gray AN Act Regulating the Retail Sale of Authentic and Imitation Indian Arts and Orafts to Prevent Misrepresentation in the Sale Thereof; Requiring Labeling of Imitation Indian Arts and Crafts and Providing a Penalty for Violation. Be It Enacted by the Legislature of the State of Washington: Section 1. SHORT TITLE. - This act may be cited as the "Indian Arts and Crafts Sales Act." DEFINITIONS. - As used in the Indian Arts and Crafts Sales Act: Section 2. A. "Indian Tribe" means any Indian tribe, organized band, or Eskimo which is domiciled in the United States; B. "Indian" means any person who is a member of any Indian tribe, and any person who is a lineal descendant of such member and possessing not less than one-quarter Indian or Eskimo blood;

- C. "Imitation Indian arts and crafts" means any Kachina doll, ring, neclace, earrings, cuff links, tie clasp, tie bar, bracelet, choker, pin, pendant, barette, bolo tie, belt, belt buckle; placque, or wood, stone, and bone carving or etching;
  - (1) made by machine, or
- (2) made either wholly or partially out of synthetic or artificial materials, or
- (3) the basic article of which is not made by Indian labor or workmanship;
- D. "Authentic Indian arts and crafts" means any kachina doll, ring, necklace, earrinns, cuff links, tie clasp, tie bar, bracelet, choker, pin, pendant, barette, bolo tie, belt, belt buckle, placque; wood, stone, and bone carving or otching which is not an imitation Indian art or craft;

containing the words "Indian Imitation" in letters not less than fourteen - point type and the imitation Indian arts and crafts shall be clearly labeled by the use of a display card in letters of not less tham one and one-half inch im height containing the words "Indian Imitation". The label and display card shall be maintained to designate the imitation Indian arts and crafts at all times.

Section 6. PENALTY. - Any merchant intentionally violating any of the provisions of the Indian Arts and Crafts Sales Act shall be purnished by a fine of not less than two hundred and fifty dollars (250.00) nor more than one thousand dollars (\$1000.00), one year, or by both such fine and imprisonment.

Section 7. SEVER BILITY. - If any part of application of the Indian Arts and Crafts Sales Act is held invalid, the remainder of the act or its application to other situations or persons shall not be affected.
