





TERMS AND CONDITIONS OF SALE

- 1. ACCEPTANCE OF ORDERS: All orders and contracts are subject to acceptance at the factory and to the conditions listed below.
- 2. PRICES: Prices are for merchandise F.O.B. Factory, U.S.A. and are subject to change without notice.
- 3. PACKING CHARGES: Are included in the selling price for all domestic shipments. Overseas shipping is subject to review to cover additional packing charges.
- 4. ROUTING: Routing will be subject to choice of the Company.
- 5. TAXES: The Company's prices do not include applicable taxes and these taxes must be borne by purchaser, or the purchasee shall provide the Company with a tax exemption certificate acceptable to the taxing authorities.
- 6. TERMS: Except as otherwise indicated, payment is due 30 days after date of shipment on approved credit. 2% 10 days shall apply to orders approved for open account terms. 5% for cash with order discounts to apply to orders paid for in full at time of placement of order only. Letters of credit are required to be of the irrevocable type and confirmed by an acceptable bank. Interest at the maximum legal rate from date of shipment will be charged on all past due accounts.
- 7. TERMS OF SALE ON CUSTOM FABRICATIONS: Shall be subject to a deposit of not less than 50% of the full selling price. Balance of order to be shipped C.O.D. or on approved open account terms.
- 8. CANCELLATION: At the Company's option, cancelled orders are subject to payment of cancellation charges equal to all costs incurred.
- 9. RETURN OF GOODS: Written permission from the factory must be obtained before returning any merchandise. All transportation charges must be borne by the customer. New, Unused material of current design accepted by the Company for credit is subject to a restocking charge of at least 15%. Products which are obsolete or made to special order are not returnable.
- 10. CLAIMS: All goods shall be deemed delivered to purchaser at the time they are placed in the hands of carrier and consigned to purchaser; loss. damage or destruction of said merchandise is assumed by purchaser.
- 11. DELAYED DELIVERIES: The Company shall not be liable for any delay in shipping or delivery of merchandise for any cause whatsoever unless it is caused solely by the negligence of the Company.
- 12. SUBSTITUTION: The Company reserves the right to substitute materials and modify specifications to the extent required in order to comply with any Government law or regulation.
- 13. CONSIGNMENT: The Company does not furnish any consigned stock whatsoever. All shipments will be made in accordance with our regular terms of payment. Notations on the order such as "to be paid for when sold," "on trial," or "when satisfactory" shall not bind the Company.
- 14. SALES POLICY: Nothing herein shall be construed as abridging the right of the Company to sell directly or indirectly to; (1) Federal and State Governments or Agencies thereof, or to Agencies employing Federal or State Government Aid; (2) Purchasers who buy Company's products for sale as integral or assembled parts of their product; (3) Firms operating on a national scale; (4) Any other class of purchaser to whom the Company may from time to time elect.

 No allocations of, or reference to any territory in which any distributor, jobber or dealer operates shall be deemed exclusive.
- 15. CONDITIONS: All sales made by the Company are subject to these conditions unless otherwise agreed to in writing with a duly authorized officer of the Company.


