If the item has not gone "sky high," I wish to obtain a Clarence King, Mountainedring in the Sierra Nevadas. If there appears to be no opportunity of obtaining a copy within several weeks, please advise.

Three weeks ago I was in L.A. with an attorney and Indian 'ribal Council delegation and while one evening (we were there only two days) we drove by the Book Store, I did not have a chance to contact you during the day.

We had consultations etc. with a "foster son" and attorney regarding the Nipo Strongheart collection, bequeathed to the Yakima Tribe. Our purpose was to check the artifacts etc. and see if they were worth recoveri Nipo, long time adviser in Indian films such as Pony Boy, Across the Wide Missouri etc. was a part Yakima. His collection had been in storage many years and no one knew exactly what it contained. The matter is now being finalized. The tribe surrendered a #15,000 bequest for a museum start and part of a scholarship request. His will is very specific but there are irregularities under a statute in California law and it got quite complicate but is being worked out ata satisfactorily. The Yakimas named me a "delegate with the Tribal Council Chairman and three other Indians to go to the storage place one of the Lyons, and check. We found it stored in seven vaults! There is from eight to ten tons of the material, including 18,000 books and pamphlets mostly on the American Indian! This the tribe wanted for research, claims cases etc. We didn 't go over things, box by box, too much. There are pounds and pounds of rare Hopi and Navajo necklaces, trunk after trunk of old Navajo rugs, including one I am sure is a genuine Beyeta, costumes of many tribes (Nipo told me he had one for each tribe in the country) and porcupine work which antedated the beadwork, etc. etc. we saw a dozen finely decorated porcupine costumes. They're worth w400 to \$:

I am quite close to the attorney and chairman and it may be I will be sent down on another UNITED flight to check material into van for home transport. I have told them about your fair dealings and if there are duplications or material useless to them I told them it could be catalogued for you for an estimate. He had some material that has apparently temporarily disappeared. I've not seen this but it is supposed to be a Shakespear "folio which he valued highly. He told me his entire collection, in the old days, was valued at at least \$200,000 and after seeing the part we inspected, I don't dubt it. He had two hand written documents on the "eno courts martial, taken at the time of the hearing, but these weren t in the well packed and preserved boxes we examined.

If I come down with one of the councilmen to check the material out and run a recheck on the storage company's files, I will advise you in advance and try and get to meet you and introduce you to the tribal official. We stayed at the Beverly Sheraton motor inn on Wilshire last time and I suspect it will be the same place. (Thetribe is just now working out it's 1968-69 budget and it runs close to \$3 million) so the Yakimas aren't to be sneezed at) They specifically wanted the books for the research material or you would have been called in before we went down.
