I'm chairman of observers which include a state senator, two preachers, two authors and president of State Federation of Women's Clubs. Much "history" being written at such sessions. Two have been recessed, because of tribal councilman's death, but will reconvene Monday and will probably go through "uesday. Construction permit has come through for Priest Rapids Ram which will run \$340,000,000 (million) and \$18,000,000 transmission lines for Priest Rapids and Wanapum Dams; project people now want conference with me relative to compensation for my little bedraggled non-treaty Wanapums (five in all) who are protected by Article 42 of construction permit.

Of course I have to handle all the mesearch, negotiations etc. at my own expense, whereas a tribal attorney for a treaty tribe would be guaranteed, by government, 10 per cent. Oh well, it will mean much preservation of culture, the last of the real old culture, and perhaps recognition that few obtain or achieve in the Indian field. Construction will start midsummer, rock pairtings will be removed from the island that is the genesis of the Wanapums etc. etc. which will be good publicity in this region at least for Drummers and Dreamers.

The future of all Indian tribes in America is being patterened on "consultation" and "termination" of three tribes, one being the Yakima, so it may be that things will move fast enough I can do a little editing of proofs of "rummers and Preamers and get some real history therein. That is just my suspicion. It will be more evident later.
