Re: Senate Joint Resolution #13

## Dear Governor Evans:

As President of Gardena-Touchet Taxpayers' Association, I have been directed by the membership representing most of the seed growers in the Gardena and Touchet communities in Walla Walla County to again call to your attention the prime necessity of securing enactment of Senate Joint Resolution #13.

A constitutional limitation on property valuations fixed at not to exceed 25% of true and fair value is clearly warranted in the opinion of our membership.

On March 15, 1967 the members of our Association again unanimously adopted a Resolution to this effect, urging you and the members of our Legislature to strongly support Senate Joint Resolution #13 without amendment.

Since the decision of the Supreme Court about a month ago indicating a 50% of true value limitation under current law, taxpayers, particularly farmers, are greatly alarmed. This is particularly true when we read that so-called representatives of school groups, welfare groups, labor groups and others are already pressing for additional taxes. They seek special benefits for their particular interests based on tax increases computed on property valuations up to 50% of true and fair value --- this is indeed a dangerous trend.

If our citizens do not become aroused and head off such a movement, our taxes will mount to the confiscatory level.

In Walla Walla County, our Assessor has raised property valuations for 1967 tax purposes, the raises ranging from 10% to more than 150% of the valuations used for 1966 tax assessments. Bond issues are being multiplied. Farm costs are mounting. The time for retrenchment in Government expenditures is upon us if we are going to survive economically.

We strongly urge you and the Legislature to cooperate in a program of retrenchment.

Enactment of Senate Joint Resolution #13 will be a vital step in such a program.

> The resolution was re-adopted because Touchet growers were added to the association since the previous meeting.

> Angry taxpayers protested the manner in which the re-valuation was carried out and declared they had no prior notification of what was happening until they received their tax statements in February.

Seed-growing lands, they said, have been re-valued higher than other farm land in the county, ranging from 20 per cent to 3,000 per cent on one small tract of 10 acres described as "worthless slough."

The taxpayers contend they have been denied due process of the law by failure of the county Please See Page 5, Col. 4

to notify them of the change in time to obtain relief by the Board of Equalization. They said they want to avoid court action but if necessary they are considering it.

They will pay 1967 taxes un-der protest reserving the right to sue to recover what has been considered the unlawful excess.

County Assessor Lloyd Hark-ins earlier told the organization that they could appear before the Board of Equalization next July and receive help for the future valuations.

The increase in valuation is on land only and covers most of the seed growing area. John Munns, president, said they hoped to increase the membership of the Association to more than 5,000 acres.

The resolution passed calls for promoting the enactment of SJR 13 with the hope that the people of the state may vote on a constitutional amendment limiting valuations of property for tax purposes to 25 per cent of true and fair value.

Other officers are Larry Bussell, vice president; Roy Kregger, second vice president; ger, Stanley Wagone, Stanley McCubbins, Clan McCubbins, Wagoner. secretary treasurer Elmer Ingham, John Weaver and Duane Dodd will serve with the officers as board members.
